Updated – 15 December 2025

This Examination Library relates to the East Midlands Gateway Phase 2 (EMG2) and East Midlands Gateway Rail Freight Interchange Material Change (EMG1MC) applications. The library lists each document that has been submitted to the examination by any party and documents that have been issued by the Planning Inspectorate. All documents listed have been published to the National Infrastructure's Planning website and a hyperlink is provided for each document. A single library is being used for both projects to seek to simplify referencing.

A unique reference is given to each document; these references will be used within the Report on the Implications for European Sites (if issued) and will be used in the Examining Authority's Recommendation Report to the Secretary of State. The documents within the library are categorised either by document type or by the deadline to which they are submitted.
