**RE: Planning Act 2008 – Section 55
Application by Horizon Nuclear Power for an Order granting Development Consent
for the Wylfa Newydd Nuclear Power Station
Adequacy of consultation request**

Thank you for your letter dated 04/06/2018 inviting the Isle of Anglesey County Council (“County Council”) to submit representations regarding the applicant’s (“Horizon”) compliance with S.42, S.47 and S.48 of the Planning Act 2008 (“the Act”).

This letter (together with the appendices set out below) forms the County Council’s Adequacy of Consultation response pursuant to section 55(b) of the Act.

Appendix A: Chronology of the Applicant’s Pre Application Consultation;
Appendix B: IACC’s responses to Horizon’s Statements of Community Consultation;

Please note that this response assesses the applicant’s methodology, approach and execution of its pre-application consultation and it is submitted to assist the Secretary of State in determining whether to accept the application.

1. Compliance with Section 47 – Duty to Consult Local Community

Section 47 of the Act sets out the ‘*Duty to consult the local community*’. The relevant subsections require that:-

- (1) The applicant must prepare a statement setting out how the applicant proposes to consult, about the proposed application, people living in the vicinity of the land.
- (2) Before preparing the statement, the applicant must consult each local authority that is

- within section 43(1) about what is to be in the statement.
- (3) The deadline for the receipt by the applicant of a local authority's response to consultation under subsection (2) is the end of the period of 28 days that begins with the day after the day on which the local authority receives the consultation documents.
- (4) In subsection (3) "the consultation documents" means the documents supplied to the local authority by the applicant for the purpose of consulting the local authority under subsection (2).
- (5) In preparing the statement, the applicant must have regard to any response to consultation under subsection (2) that is received by the applicant before the deadline imposed by subsection (3).
- (6) Once the applicant has prepared the statement, the applicant must publish it—
 - (a) in a newspaper circulating in the vicinity of the land, and
 - (b) in such other manner as may be prescribed.
- (7) The applicant must carry out consultation in accordance with the proposals out in the statement.

Horizon prepared three separate Statements of Community Consultation (see chronology in **Appendix A** for detail) which outlined how they proposed to consult about the proposed application with the people living in the vicinity of the proposed development. The IACC was consulted and responded in each case (**Appendix B**). This was undertaken in the requisite period satisfying the County Council that the requirements of subsections (1), (2), (3) and (4) were adequately discharged.

In respect of sub-section (5), Horizon considered the Council's response and wrote back to confirm changes made in direct response to the Council's comments. Although IACC has concerns with the length and scope of the PAC3 consultation (as outlined in **Appendix C**), the Council is satisfied that Horizon has complied with Sub-section (5), with comments raised being given due consideration in the development of the proposed Statement.

In accordance with subsection (6), Horizon published the SOCC in a number of local newspapers as well as advertising through other means such as websites, social media, etc. As such, the County Council is satisfied that Horizon adequately discharged its duty to publish the SOCC.

Given the significant changes to the project proposal from PAC2 to PAC3 (as recognised by Horizon in the May 2017 version of SOCC¹), the County Council did raise a number of concerns in response to that SOCC (**Appendix B**). For example, the change to their Construction Worker Accommodation Strategy has resulted in an increase from 500 'essential workers' on-site to up to 4,000 construction workers accommodated on-site in a purpose built temporary campus. This is a substantial change to the project, which materially changes the approach to construction worker accommodation and, therefore, the impacts which will occur during the construction period on local communities. The County Council believes that this change required a more detailed consultation than the 30 days provided. Furthermore, there were no details or technical drawings for the on-site campus included within PAC3, which meant that the public could not provide comments on the proposal during the consultation to meaningfully shape and influence the proposed development. The DCO application will be the first opportunity the public will have to see this detail, which is regrettable, but not fatal to the acceptance of the application.

Notwithstanding this, in accordance with subsection (7) above, Horizon did consult in accordance with the proposals in their SOCC and, therefore, the IACC is satisfied that Horizon has complied with the minimum legal requirements of Section 47 of the Planning Act 2008.

2. Compliance with Section 42 – Duty to Consult

This section requires the applicant to consult the following about the proposed application—

- (a) *such persons as may be prescribed,*
- (b) *each local authority that is within section 43,*
- (c) *the Greater London Authority if the land is in Greater London, and*
- (d) *each person who is within one or more of the categories set out in section 44.*

Based on the information provided in Horizon's Consultation Report, the Council considers that Horizon has consulted the various bodies as required. So far as the scope of the consultation is concerned, the County Council considered that the omission of details, plans and mitigation measures from PAC2 and, in particular, PAC3 made it difficult for the Council to respond as fully and meaningfully as it would have wished to. Horizon and the County Council have since, however, been in dialogue regarding this and further detail has been shared with the County Council allowing it to better understand and comment on proposals. In particular, the approach to mitigation has developed and discussions on plans and strategies have progressed meaningfully. In view of this, the County Council considers that Horizon's duty to consult under Section 42 has now been met.

3. Compliance with Section 48 – Duty to Publicise


Section 48 of the Act imposes a Duty to Publicise in a prescribed manner.

Horizon's Consultation Report provides details of how it has complied with Section 48. A copy of the Section 48 notice was advertised notifying its intention to apply for a DCO. This was placed in a number of newspapers for two consecutive weeks. The press notice also provided a deadline for the receipt of responses. In view of the above, the Council is satisfied that Horizon's duty to publicise under Section 48 has been carried out.

Conclusion

Although the County Council believes that the 30-day consultation for PAC3 was less than what would have been ideally allowed for consultation, in IACC's view Horizon has adequately consulted in accordance with the provisions of sections 47, 42 and 48 of the Act.

This assessment has informed the IACC's response as to whether Horizon have complied with S.42, S.47 and S.48 of the Planning Act 2008.
