Dear Sir/Madam,

Thank you very much for your letter regarding the Wylfa Newydd Nuclear Power Station.

In 2017 the Netherlands government expressed the wish to participate in the EIA Regulation 24 process for a new nuclear power station at Wylfa, Anglesey, North Wales. The reason for this wish is to make a judgement by the ANVS about the risk of transboundary pollution on the territory of the Netherlands, especially in case of a major accident or incident.

Based on the Transboundary Effects Assessment in Applicant's documentation, i.e. the impact assessment of accidental releases, the Netherlands considers that the Proposed Development is not likely to have a significant effect on the environment in the Netherlands.

We confirm – however – that the Ministry of Infrastructure and Water Management wants to be registered as a interested party to be kept informed about the process of project.
