1 Statutory Undertaker and Special Category Land – s.127, 132 and 138 Schedules

1.1 Introduction

- 1.1.1 This note has been prepared in response to the request by the Examining Authority in its Rule 8 Letter [PD:010] for a schedule in relation to statutory undertakers' land and special category land and the extinguishment of rights and removal of apparatus of statutory undertakers etc. including how the Applicant intends to satisfy sections 127, 132 and 138 of the Planning Act 2008.

1.2 Statutory Undertakers Land, Rights and Apparatus

- 1.2.1 Appendix 1-1 includes a schedule identifying all plots that are "statutory undertakers' land" as defined in section 127 of the Planning Act 2008.
- 1.2.2 Appendix 1-2 includes a schedule identifying all plots where there subsists over that land a "relevant right" or there is on, under or over the land "relevant apparatus" belonging to a statutory undertaker as defined in section 138 of the Planning Act 2008. This schedule has been divided into five parts, one for each development site affected.
- 1.2.3 As demonstrated in these schedules, the following statutory undertakers have been identified as affected or likely to be affected by the Wylfa Newydd DCO Project.
- 1.2.4 Horizon continues to engage with these statutory undertakers in relation to which of their land, rights and/or apparatus are to be retained and which are to be extinguished or suspended. The table below summarises the status of discussions between Horizon and these statutory undertakers.

1.3 Special Category Land

- 1.3.1 Table 1-2 lists the one plot of special category land identified in the Special Category Land Plan [APP-010]. As Table 1-2 details, this plot has been classified as Class 6 in the Book of Reference [APP-034, 035 and 036] meaning that the land is not subject to powers of acquisition.
- 1.3.2 The Order Land does not include any common, open space or fuel or field allotment land within the scope of section 131 or 132 of the Planning Act 2008.
- 1.3.3 On this basis no special category land schedule is required.
