## 1 DCO Action Points

<b>Schedule 15 - Protective Provisions of the Draft DCO</b>	
1. Magnox	<ul style="list-style-type: none"><li>Protected Provisions have been agreed and will be included in the Deadline 4 (17<sup>th</sup> January 2019) update to the Draft DCO.</li></ul>
2. Welsh Water	<ul style="list-style-type: none"><li>Protected Provisions have been reviewed by Horizon and will be provided back to Welsh Water for comment week of 14 January.</li><li>Pending comments from Welsh Water, Horizon anticipates that Protected Provisions can be included in the next update of the Draft DCO.</li></ul>
3. National Grid	<ul style="list-style-type: none"><li>Protected Provisions have been reviewed by Horizon and provided back to National Grid for comment on 2<sup>nd</sup> January 2019.</li><li>Pending comments from National Grid, Horizon anticipates that Protected Provisions can be included in the next update of the Draft DCO.</li></ul>
4. Nuclear Decommissioning Authority (NDA)	<ul style="list-style-type: none"><li>NDA has been included within the Magnox Protected Provisions and these have been sent to them for comment.</li><li>Horizon are awaiting confirmation from the NDA on their preferred position as they have advised that they may wish to agree their own bespoke protective provisions.</li></ul>
5. IACC Highways	<ul style="list-style-type: none"><li>Amended Protected Provisions have been drafted by Horizon and are to be sent to IACC as soon as possible.</li><li>Pending comments from IACC, Horizon anticipates that Protected Provisions can be included prior to the end of examination.</li></ul>

<b>Schedule 15 - Protective Provisions of the Draft DCO</b>	
6. Network Rail	<ul style="list-style-type: none"><li>Network Rail and Horizon have discussed anticipated impacts on their infrastructure and Horizon is amending the Network Rail Protective Provisions following these discussions.</li><li>It is anticipated that Protected Provisions can be agreed prior to the end of examination.</li></ul>
7. SPEN/SP Manweb	<ul style="list-style-type: none"><li>Draft Protected Provisions currently being reviewed by SPEN.</li><li>Pending comments from SPEN, anticipate Protected Provisions can be included prior to the end of examination.</li></ul>
8. Wales and West Utilities	<ul style="list-style-type: none"><li>Initial discussions and meeting to be held to discuss impacts. Awaiting confirmations from Wales and West Utilities for a follow up meeting.</li><li>Pending comments from Wales and West Utilities, Horizon anticipates Protected Provisions can be included prior to the end of examination.</li></ul>
9. Telecoms: BT Openreach, Zayo Group, Centrica, CenturyLink, Telefonica	<ul style="list-style-type: none"><li>Horizon has sent letters to these statutory undertakers; however there has been no engagement to date.</li><li>Horizon is continuing to seek responses; however, there are Protective Provisions currently within the Draft.</li></ul>
