1 Crown Land and Interests s.135 Schedule

1.1 Introduction

1.1.1 This schedule identifies all plots owned by, or in which the Crown holds an interest as defined by sections 227(3), 227(4) and 135(4) of the Planning Act 2008. For each plot, the plot number, description and interest to be acquired is identified. Each entry indicates the state of the negotiations for acquisition of the interest with the relevant Crown body.

1.1.2 Horizon intends to acquire the relevant Crown land by negotiation. As part of those negotiations, it will seek to secure any requisite consent from the Crown body pursuant to section 135(1) of the Planning Act 2008 to acquire any other interest in Crown land using compulsory acquisition powers should it not be possible to acquire these by negotiation.

1.1.3 Horizon is also seeking to secure consent under section 135(2) of the Planning Act 2008 to the other provisions of the draft DCO applying in relation to Crown land or rights benefiting the Crown.

1.1.4 To this end, Horizon:

- a) is in discussions with the Crown Estate to finalise its section 135 consent letter in respect of the Crown Estate land and interests; and
- b) has formally requested a section 135 consent letter from the Welsh Government in respect of the Welsh Government land interests.

1.1.5 Horizon expects that it will be able to secure the necessary consents from these Crown entities prior to the close of Examination.
