**Local Labour Force (During Construction)**

On the afternoon of the 15<sup>th</sup> April 2019 the examining authority published a request for further information. Noted below is request R17.2.5.7 that asks Horizon and NACP to provide a joint statement by deadline 10.

R17.2.5.7	Applicant and North Anglesey Council Partnership	D10	Provide a joint statement in response to North Anglesey Council Partnership's D9 submission [REP9-033] to clarify the situation with regards to the 'local workforce' recruitment estimates for North Anglesey/Anglesey and any implications that this may have for the application.

The NACP have emailed the applicant and our understanding is that the remaining DCO team will arrange a meeting between the NACP and Horizon to progress this as a matter of urgency. The NACP will endeavour to provide the statement before closure of the examination.

The NACP note the applicant's statement on the "*challenge of analysing data at a more granular geographic level*" (REP8-012 3.1.4). It is the NACP's view that this may be the case at a North Anglesey level as this area comprises the Talybolion and Twrcelyn wards in full and part of Lligwy ward. The NACP have a general awareness of the Statistical Disclosure Control Methods used by the Office for National Statistics (ONS). Confidentiality of individuals can be protected through aggregation, cell modification and data adjustment and the use of these methods would, in the view of the NACP, provide robust, but rather dated, 2011 Census data at the Anglesey and the 60 minute Travel to Work Area.

As it is unlikely that a joint statement can be agreed prior to deadline 10 the NACP wish to submit the following evidence that concatenates data of local workforce availability estimates against recruitment estimates at peak. This data was published by the applicant in APP-096 and REP8-012. The NACP have also calculated the ratio between the two figures. A small ratio indicates that recruitment is more challenging and a large ratio indicates the contrary.

The NACP remain concerned that the potential recruitment estimates for local workers may be over-optimistic. It continues to be the NACP's view that this may impact accommodation requirements, may impact traffic calculations, may result in significant local displacement, may require substantial further investment in the area of training and/or retraining and may require a redoubling of efforts to contact suitably skilled workers who may have left the area to seek work.
