Dear Inspectorate,

It is with such a heavy heart I right this final representation to you as I have felt from day one you gave me a voice but as this is the final day I feel so heartbroken that the applicant is ignoring the case that we are on their boundary as you saw on your site visit to my home and as mitigation goes they are not responsible for the relocation of both my family and my business. They have told me that in their response to the secretary of state I will not be mentioned.

I came and address the inspectorate for the following reasons:

as from day one the applicant had completely refused the fact that they had ignored us on the application as "we are just tenants".

They ignored my multi award winning business and classed it as a farming business within a 5km radius (we are on their boundary)

All of the other affected parties and businesses in the same radius have been relocated compensated and demolished yet I'm still here being brushed to one side as if my life does not matter because I am just a tenant.

The way they have [REDACTED] me in this whole process is immoral and I fear that someone with less strength and support would of either given up or [REDACTED]

I have given them 15 months to recognise this but they have simply failed to do so.

Every day I live monitoring my emails for news and monitoring social media and parliament TV when and if I will lose everything and at present there is no way out for [REDACTED] and my lovely business.

We have nowhere to go at present and I can't even think of the future but I must keep fighting for my family and they business I have worked so hard to build as non of this is my making.....

Any project that effects local communities, businesses and people no matter if it is a project of national significance should mitigate the disruption it causes as it is not the fault of the people that this happens and I should not have to sacrifice my quality of life or lose my animals without them taking responsibility that they are doing this and at present they don't.

This is and never has been what they are doing but the way they are doing this is wrong. [REDACTED]
[REDACTED] as I think they always knew they would and they have [REDACTED] but I have no option but to keep fighting as I still believe we live in a just fare society but what is happening here at present is not just or fare.

Please please give me your voice I am literally begging you to not sacrifice my [REDACTED] and business in your final response as in a planning condition. I know I'm not a massive business

like a NRW condition or a National trust condition but I matter, I am an individual, a wife, a mother, a boss, a human being [REDACTED]

Once again thank you for giving me a voice.
