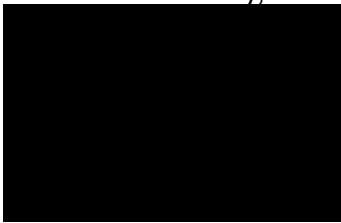


set out in the third column of that table, in accordance with section 72(3)(d) of the Marine and Coastal Access Act 2009.
