Application EN010012 for The Sizewell C Project by NNB Generation Company (SZC) Limited ("SZC Co.")

We write further to your letter, dated 22 January 2021, regarding your request for further clarifications and documents from SZC Co. [PD-010].

Relationship between the draft Development Consent Order (DCO) and the Environmental Statement (ES)

Annex A of the 22 January 2021 Procedural Decision letter contained a number of questions regarding the relationship between the DCO and the ES. **Appendix A** of this letter provides SZC Co.'s responses to those questions.

Submitted in support of these responses are:

- (1) Schedule of Accesses (Appendix B);
- (2) Works Plans (Doc Ref. 2.3(B));
- (3) Construction Parameter Plans (Doc Ref. 2.5(B)); and
- (4) Indicative Parking Plans (Appendix C).

Other Matters

1. Proposed Change 1: Potential to increase the frequency of freight train movements

The 22 January 2021 Procedural Decision letter requested an update on the ongoing negotiations with Network Rail and freight operating companies, along with an outline of the intended approach and any implications for the change request should the potential not be realised. At **Appendix D** of this letter is a note, jointly prepared by SZC Co. and Network Rail, addressing these points.

2. Land Changes Plans

The 22 January 2021 Procedural Decision letter requested a further version of the Land Changes Plans [AS-152]. These 'Land Plans showing Proposed Land Changes' are provided in support of this letter (Doc Ref. 4.5).

The 'Land Plans showing Proposed Land Changes' identify the rights sought in each plot if the proposed changes were accepted by the Examining Authority, using shading consistent with that in the Land Plans included in the Application. Where this represents a change from the Application, a hatching has been applied to the plot to show how the rights sought, if accepted by the Examining Authority, would vary from those shown in the Application.

3. Beach Landing Facility ("BLF")

The 22 January 2021 Procedural Decision letter requested a visualisation of the enhanced permanent BLF when in use. In addition to providing the requested visualisation for the operational phase of the project, SZC Co. has also provided in support of this letter the visualisation of the temporary and permanent BLFs when in use during the construction phase of the Project. These are presented as supporting appendices to those submitted in Volume 2, Chapter 2 of the Environmental Statement Addendum (Doc Ref. 6.14).

4. Unredacted statutory consultee responses

The 22 January 2021 Procedural Decision letter asked SZC Co. to provide an unredacted version, in respect of statutory consultee responses only, of Book 5, 5.1 Consultation Report Addendum Annex A. This is provided in support of this letter (Doc Ref. 5.1Ad I - CONFIDENTIAL).

5. Draft DCO

As requested by the Examining Authority, submitted in support of this letter are a Microsoft Word version of the draft DCO showing changes between versions 1 and 3 (see **Appendix E** to this letter) and SI template validation reports for version 2 (Doc Ref. 3.3(A)) and version 3 (Doc Ref. 3.3(B)) of the draft DCO. The SI template validation report for version 1 of the draft DCO was provided with the Application in May 2020 [APP-061].

Air Quality Appendices

In preparing this submission, it has come to SZC Co.'s attention that the Volume 3, Chapter 9 Environmental Statement Addendum Air Quality Appendices 9.4.A-9.4.B (Doc Ref. 6.14), which were intended to comprise part of SZC Co.'s submission on 12 January 2021, had erroneously been excluded from the bulk upload to the data room. These are, therefore, submitted with this letter.

Attached is a revised version of the Navigation Document (Doc Ref. 1.3(E)).
