## 1 OTHER CONSENTS AND LICENSES

### 1.1 Purpose of this document

1.1.1 The principal consent for the construction, operation and maintenance of the ‘Sizewell C Project’ (i.e. all components of the nuclear power station itself, as well as associated developments, which are the works required to facilitate development of the power station. will be an order made by the Secretary of State for development consent (the ‘DCO’) under section 103 of the Planning Act 2008 (the ‘Act’). The DCO will include the legal powers and rights required in order to construct, operate and maintain the Sizewell C Project. The DCO application will, however, need to be supplemented by other applications because:

- a specific consent cannot be contained in the DCO;
- a consenting authority declines to allow a consent to be obtained in the DCO; or
- it is not desirable, or it is inappropriate, to include a consent within the DCO due to the stage of design development and the level of detail available.

1.1.2 This report identifies the other consents, licences and agreements that are required to allow the construction, operation and maintenance of the Sizewell C Project which fall into the three categories listed above. As designs, techniques, methodologies and regulatory regimes evolve, SZC Co. will ensure that the correct consents, licences and agreements are obtained (by SZC Co. or by other companies in the EDF Energy Group) at the relevant times to comply with legislation.

1.1.3 This document is not in itself a requirement of Infrastructure Planning (Applications: Prescribed Forms and Procedure) Regulations 2009 but supplements the response to Box 24 of the **Application Form** [\[APP-006\]](#) which relates to ‘details of other consents / licences required under other legislation’.

1.1.4 Paragraph 45 of the former Department for Communities and Local Government Planning Act 2008: Application Form Guidance (June 2013) provides the following guidance in this regard:

*"Where the proposed development will also require other consents, licences, permits, etc, to enable it to be constructed and/or operational, and for which the Secretary of State is not the authorising body under the*

*Planning Act, then the applicant must list and briefly describe these in Box 24. Reference should be made to any that have already been applied for, and a copy enclosed of any that the applicant may already be in the possession of. Such other consents could be required for controlling pollution, for example".*

- 1.1.5** In providing a suggested order of information submitted with a DCO application, the PINS *Advice Note Six: Preparing and submission of application documents (November 2019)* – whilst confirming that this document is not a statutory requirement – suggests that details of other consents and licences would sit within the ‘Reports / Statements’ category.
- 1.1.6** This schedule was updated at Deadline 3 of the Examination as follows:
- To reflect the Environmental Statement Addendum [AS-179 to AS-260];
  - To refer to the second planning permission for the Sizewell B relocated facilities;
  - To insert the Flood Risk Activity Permits and Land Drainage Consents for the fen meadow sites;
  - To insert desalination in relation to the construction water discharge activity permits and abstractions licenses;
  - To reflect progress and updates to the nuclear-related permits.
- 1.1.7** This schedule was updated at Deadline 7 of the Examination as part of the Change Application (August 2021) as follows:
- To provide further clarity on the Flood Risk Activity Permit, Construction Water Discharge Activity Permits and Water Abstractions Licences in relation to the desalination plant.
- 1.1.8** This schedule has been updated at Deadline 10 of the Examination as follows:
- To update on the status of the “ghost” protected species licences (i.e. drafts provided to Natural England).
  - To reflect the positive outcome received for the Article 37 submission (for any plans for the disposal of nuclear waste).

- To incorporate additions requested by East Suffolk Internal Drainage Board in respect on the required Land Drainage Consents required by the Sizewell C Project.

## 1.2 Structure of this report

1.2.1 This report identifies the required additional consents and licences for each of the development components of the Sizewell C Project. Within each chapter the term “proposed development” refers to the development described in the description of development chapter(s) within the relevant volumes of the **Environmental Statement (ES)** [APP-159 to APP-582], as updated by the subsequent **ES Addenda** [AS-179 to AS-292, REP5-062 to REP5-069, REP6-017, REP7-029 to REP7-0033 and REP8-072 and REP8-073]. The chapters are structured, as follows:

- **Chapter 2** – Main Development Site, including the ecological mitigation sites (as described in **Volume 2, Chapters 2 to 5** of the **ES**, updated by **Volume 1, Chapter 2** of the **First ES Addendum**, **Volume 1, Chapter 2** of the **Second ES Addendum**, and **Volume 1, Chapter 3** of the **Fourth ES Addendum**)
- **Chapter 3** – Rail (as described in **Volume 9, Chapter 2** of the **ES**, updated by **Volume 1, Chapter 9** of the **First ES Addendum**)
- **Chapter 4** – Sizewell Link Road (as described in **Volume 6, Chapter 2** of the **ES**, updated by **Volume 1, Chapter 6** of the **First ES Addendum** and **Volume 1, Chapter 4** of the **Second ES Addendum**)
- **Chapter 5** – Two Village Bypass (as described in **Volume 5, Chapter 2** of the **ES**, updated by **Volume 1, Chapter 5** of the **First ES Addendum** and **Volume 1, Chapter 3** of the **Second ES Addendum**)
- **Chapter 6** – Northern Park and Ride (as described in **Volume 3, Chapter 2** of the **ES**, updated by **Volume 1, Chapter 3** of the **First ES Addendum**)
- **Chapter 7** – Southern Park and Ride (as described in **Volume 4, Chapter 2** of the **ES**, updated by **Volume 1, Chapter 4** of the **First ES Addendum**)
- **Chapter 8** – Freight Management Facility (as described in **Volume 8, Chapter 2** of the **ES**)

- **Chapter 9** – Yoxford Roundabout and Other Highway Improvements (as described in **Volume 7, Chapter 2** of the **ES**, updated by **Volume 1, Chapter 7** of the **First ES Addendum**)

1.2.2 The other consents, licences and agreements identified in the tables in each of these chapters have either already been obtained or would be sought separately from the DCO. SZC Co. sees no impediment to obtaining any of these consents, licences or agreements.

### 1.3 The Sizewell C Project

1.3.1 The proposed Sizewell C nuclear power station would comprise two UK EPR™ units with an expected net electrical output of approximately 1,670 megawatts (MW) per unit, giving a total site capacity of approximately 3,340MW. The design of the UK EPR™ units is based on technology used successfully and safely around the world for many years, which has been enhanced by innovations to improve performance and safety. The UK EPR™ design has passed the Generic Design Assessment process undertaken by UK regulators (Office for Nuclear Regulation and Environment Agency), and has been licenced and permitted at Hinkley Point C. Once operational, Sizewell C would be able to generate enough electricity to supply approximately six million homes in the United Kingdom (UK).

1.3.2 In addition to the key operational elements of the UK EPR™ units, the Sizewell C Project comprises other permanent and temporary development to support the construction and operation of the Sizewell C nuclear power station. The key elements are the main development site, comprising the Sizewell C nuclear power station itself, offshore works, land used temporarily to support construction including an accommodation campus, the enhancement of sports facilities in Leiston, fen meadow and marsh harrier compensation habitat, and a series of off-site associated development sites in the local area. These are:

- Two temporary park and ride sites; one to the north-west of Sizewell C at Darsham (the ‘northern park and ride’), and one to the south-west at Wickham Market (the ‘southern park and ride’).
- Permanent road improvements on the A12 to bypass Stratford St Andrew and Farnham (referred to as ‘two village bypass’).
- A permanent road linking the A12 to the Sizewell C main development site (referred to as ‘Sizewell link road’).
- Permanent highway improvements at Yoxford roundabout and other road junctions.

- 
- A temporary freight management facility at Seven Hills on land to the south-east of the A12/A14 junction.
  - A temporary extension of the existing Saxmundham to Leiston branch line into the main development site ('the green rail route') and other permanent rail improvements on the Saxmundham to Leiston branch line.
