Dogger Bank Creyke Beck Offshore Wind Farm Order 2015 – Non-material Change Application

We act on behalf of Doggerbank Offshore Wind Farm Project 1 Projco Limited (“Projco 1”) and Doggerbank Offshore Wind Farm Project 2 Projco Limited (“Projco 2”) who have the benefit of the Dogger Bank Creyke Offshore Wind Farm Order 2015 (as amended) (the “DCO”).

A non-material change (“NMC”) application to amend the DCO has been submitted to the Secretary of State for Energy Security and Net Zero (DESNZ) by Projco 1 and Projco 2.

Previous NMC applications have already been submitted to (and approved by) the Secretary of State for the following changes to the DCO:

- on 9 April 2019, to allow each wind turbine generator to have a maximum rotor diameter of up to 280 metres;¹
- on 20 March 2020, to remove the maximum generating capacity for both wind farms;² and
- on 17 June 2022, to increase the maximum permitted hammer energy during the installation of the wind turbine and electricity substation (platform) structures.³

A further NMC application is now being sought to amend the wording of certain definitions, articles and paragraphs of schedules, to allow the two parts of the development (known as the Dogger Bank A Offshore Windfarm Project, or DBA, and the Dogger Bank B Offshore Windfarm Project, or DBB) to be considered as distinct from one another, and for the discharge and enforcement of each project’s relevant requirements (including the acquisition of each project’s transmission assets) to be distinct from the other project.

This change does not amend any project parameters of either DBA or DBB. As set out within the application documents, this amendment will comprise a “non-material” change as defined in the

Planning Act 2008 and The Infrastructure Planning (Changes to, and Revocation of, Development Consent Orders) Regulations 2011 (as amended) (the “2011 Regulations”).

You are being formally consulted by the Projects on this change as you meet the criteria set out under Regulation 7(2) of the 2011 Regulations, which means you satisfy one of the following criteria:

1. you are a person for whose benefit the DCO has effect;
2. you are a person that was, in accordance with section 56, notified of the application for the DCO; or
3. you are a person who may be directly affected by the changes proposed in the NMC.

Alongside this letter we have included the Regulation 6 Notice that has been published in Fishing News, Bridlington Free Press and The Holderness and Hornsea Gazette.
