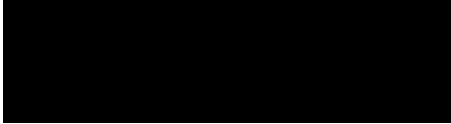
The North Killingholme - Proposed Non-Material Change Application

Regulation 7(3) of the Infrastructure Planning (Changes to, and Revocation of, Development Consent Orders) Regulations 2011 - Written consent from the Secretary of State for not consulting a person or authority

1. Thank you for your email of 4 July 2025 on behalf of Uniper UK Limited ("the Applicant"). The e-mail and attached letter of 4 July 2025 requests the Secretary of State's consent under Regulation 7(3) of the Infrastructure Planning (Changes to, and Revocation of, Development Consent Orders) Regulations 2011 (as amended) ("the 2011 Regulations") to a reduced list of consultees.
2. The Applicant proposes to consult 159 parties including the relevant Local Authorities, the Environment Agency, Natural England, Historic England, Health and Safety Executive, and the National Air Traffic Services. The applicant has provided justifications for their proposed approach, including requirements to consult different consultees. This includes where consultees have relevant interests in respect of the Environmental Statement (ES) Addendum and Habitats Regulations Assessment (HRA), because one or more of the proposed changes are located within their local authority area; or because they are an organization with land interests within the area of one or more of the proposed changes.
3. The Secretary of State is satisfied that it is not necessary for other consultees from the Order to be included in the reduced consultee list, as they are not directly affected, either because the proposed amendments will not affect their interests or because their interests relate to a different part of the scheme.
4. The Secretary of State agrees with the proposed approach to the consultation. Accordingly, the Secretary of State gives written consent for the consultation to proceed in accordance with the details set out above, under regulation 7(3) of the 2011 Regulations.
5. In taking this decision, the Secretary of State acknowledges that notice of the Application will be provided by the Applicant, in line with the requirements in Regulation 6 of the 2011 Regulations.

6. The Secretary of State's written consent on this matter should not be taken as indicating approval of any other aspects of the proposed changes to the Order, which fall to him for consideration and determination, or whether the proposed changes will ultimately be regarded as material or not.

PINS REF: EN010038 North Killingholme Generating Station Order **Proposed Non-Material Change Application**

On behalf of our clients, Uniper UK Limited ('Uniper'), who have acquired the benefit of the above DCO from the original applicants (C.Gen), Ove Arup & Partners Ltd ('Arup') write to formally notify the Secretary of State of the Department for Energy Security and Net Zero of Uniper's intention to submit an application for a non-material change to the North Killingholme (Generation Station) DCO.

We have been in contact with you by email previously on 14/04/2025, 01/05/2025, and 18/06/2025 to try to arrange a meeting with yourselves to explain the rationale for the change application and agree next steps in advance of submitting the application, particularly in relation to the consultee list.

We appreciate that DESNZ has a very busy workload, but the need for our clients to progress the proposed NMC application is now urgent in order to align internal financial approvals to move forward with the Proposed Development with the forthcoming T-4 Capacity auctions.

In accordance with 'step one' of the Guidance on Changes to Development Consent Orders (DCLG, December 2015), the applicant has prepared draft application documents, commenced arrangements for publicity and consultation, and has sought to notify the Planning Inspectorate (PINS) of their intention to submit an NMC application.

However, PINS confirmed on 03/07/2025 that they cannot progress with relevant procedural matters to make a project page available on the website and provide us with contact details for consultees to submit comments on the NMC application, until the Secretary of State has confirmed it is appropriate for these changes to be considered as an NMC application and have agreed the scope and extent of consultees to be notified of the application.

Below, we provide details of the proposed scope of the NMC application, and enclose a list setting out the consultees the applicant considers to be appropriate, proportionate and relevant in the context of the scope of the proposed changes.

1. Proposed Scope of NMC Application

The proposed changes relate to the intention to progress the development of a carbon capture enabled Combined Cycle Gas Turbine (CCGT) generating station at the site, using the existing DCO consented generating station as the basis. The design work that has been undertaken has identified a number of minor, non-material, changes needed to the DCO to enable it to be implemented, which include:

- An increase in the MW capacity named on the DCO (470MW) to align with the sizing of current turbine technology and also match the grid connection (550MW);
- A minor change to internal boundaries of Work Number 1 to enable the CCGT build to be optimised;
- Minor changes to several building parameters specified in Schedule 1 to the DCO to align with the design work undertaken; and
- Reprovision of the land set aside to meet the Carbon Capture Readiness requirements on an alternative area of land, to assist the CCGT build to be optimised, and provide a site of an appropriate size to accommodate a Carbon Capture Plant

The Applicants have undertaken studies and assessments to demonstrate that the above changes do not result in any materially new or different significant environmental effects from those set out in the original Environmental Statement that accompanied the original DCO application, or as assessed by the application documents for the DCO Amendment approved in 2021. As such, we are confident that this application should be treated as non-material and decided by the Secretary of State on that basis.

The proposed changes do not affect any new land interests.

The applicant for the proposed NMC has control over all necessary land to enable the implementation of the CCGT generation station in accordance with the DCO (subject to the changes to be set out in the change application) and also to commit to the reprovision of the alternative reserved site for CCR compliance.

2. Approach to Consultation for the change application

The applicant would also like to seek formal agreement from the Secretary of State to the proposed approach to consultation about the change application.

The proposed changes only relate to the CCGT elements of the consented DCO and not the much larger and wider biomass gasification scheme consented by the C.Gen proposals, which covers a far larger area of land and work numbers in the DCO than would be affected by this non-material change.

Accordingly, we enclose a list setting out our proposed reduced list of consultees from that which would typically be required in accordance with the relevant regulations, to reflect the scale of the proposed application, to ensure the consultation exercise undertaken is appropriate and proportionate. This list aligns with the consultee list that was previously used by C.Gen in 2021 for the non material change application made at that time.

The list also identifies consultees which the applicant does not consider it would be appropriate and proportionate to consult, and explains the reasoning for that approach.

We welcome the Secretary of State's response at the earliest opportunity on whether the proposed changes can be considered via a non-material change application, and confirmation that the proposed list of consultees is appropriate.

In addition, we welcome confirmation that the appropriate application fee, payable on submission of the application, is £6,891.00, and would be grateful for confirmation of the most appropriate mechanism for making the payment to the Secretary of State.

We would be very grateful if the Secretary of State could provide a response by **18th July 2025**, to assist Uniper's investment decision to progress the delivery of the consented carbon capture enabled CCGT generating station at the site, meeting low carbon energy generation objectives and supporting the decarbonisation of the Humber region.

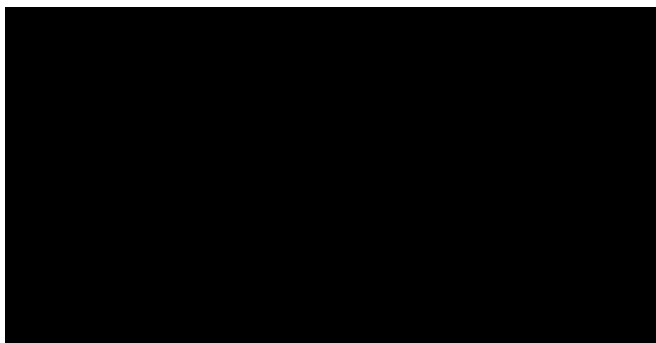
