**The Knottingley Power Plant (Correction) Order 2016**

*Made* - - - - *21st July 2016*

*Coming into force* - - *22nd July 2016*

The Knottingley Power Plant Order 2015(a), which granted development consent within the meaning of the Planning Act 2008 (“the Act”)(b), contains correctable errors and omissions within the meaning of the Act(c).

Before the end of the relevant period, as defined in paragraph 1(6)(a) of Schedule 4 to the Act, the Secretary of State received a written request from the applicant(d) for the correction of errors in the Knottingley Power Plant Order 2015 under paragraph 1(5)(a) of Schedule 4 to the Act.

The Secretary of State has informed North Yorkshire County Council, Selby District Council and Wakefield Metropolitan District Council, the local planning authorities for the area in which the land to which the Knottingley Power Plant Station Order 2015 relates is situated, that the request has been received in accordance with paragraph 1(7) of Schedule 4 to the Act.

The Secretary of State, in exercise of the powers conferred by paragraphs 1(4) and 1(8) of Schedule 4 to the Act, makes the following Order—

**Citation and commencement**

1. This Order may be cited as the Knottingley Power Plant (Correction) Order 2016 and comes into force on 22nd July 2016.

**Corrections**

2.—(1) The Knottingley Power Plant Order 2015 is to be corrected as provided for in the table in the Schedule, where—

- (a) the first column sets out where the correction is to be made;
- (b) the second column sets out how the correction is to be made; and
- (c) the third column sets out the text to be substituted, inserted or omitted.
