Application for the Inclusion of Additional Land

Through engagement with the Project's design teams and various stakeholders, the Applicant has continued to progress and refine the design of the Project since submission of the Application. This process has identified a number of areas where refinements to the Project could serve to reduce the environmental impact of the Project. However, for some of the refinements the inclusion of additional land in the Application is required. A number of other refinements have been made to the Project which do not require additional land, and details of these non-material amendments are provided within the Notice of Intent to Make Non-Material or Material Changes submitted at Deadline 1.

With respect to the proposed refinements that require the inclusion of additional land, an Application for the Inclusion of Additional Land has been submitted at Deadline 1 which sets out full details of the proposed changes. This document has been prepared in the context of section 123 of the Planning Act 2008 and Regulation 4 of the Infrastructure Planning (Compulsory Acquisition) Regulations 2010 (the Compulsory Acquisition Regulations). In accordance with Regulation 5 of the Compulsory Acquisition Regulations, the following documents have been submitted to support the Applicant's request to include additional land within the Application:

- Updated Book of Reference and Schedule of Changes to the Book of Reference;
- Updated Land Plans (Onshore);
- Updated Statement of Reasons; and
- Updated Funding Statement.

Additional Submissions

Annex B to this letter contains a list of additional submissions that are being made by the Applicant at this 2 November 2020 deadline. The Applicant notes that these documents were not requested by the Examining Authority but the Applicant considers that these provide information, clarifications and updates useful to both the Examining Authority and Interested Parties.
