5.	<ul> <li>Outline Landscape and Ecological Management Strategy (OLEMS)</li> <li>Applicants to provide a definition of 'perching' as used in para. 135 of the OLEMS [REP6-007].</li> <li>To consider whether further assessment of the additional surface water management SuDs basin capacity to reduce flood risk for Friston is required and if so to include in the revision of the OLEMS.</li> </ul>	Applicants	D8
