We write further to our letter of the 16th January enclosing a written representation on behalf of Cadent Gas Limited and reserving the right to appear at the Issues Specific Hearing on the 7th February.

We have now made progress with the promoter in relation to the Indemnity/Insurance/Surety points raised in our written representation in paragraphs 4.9 to 4.17.
