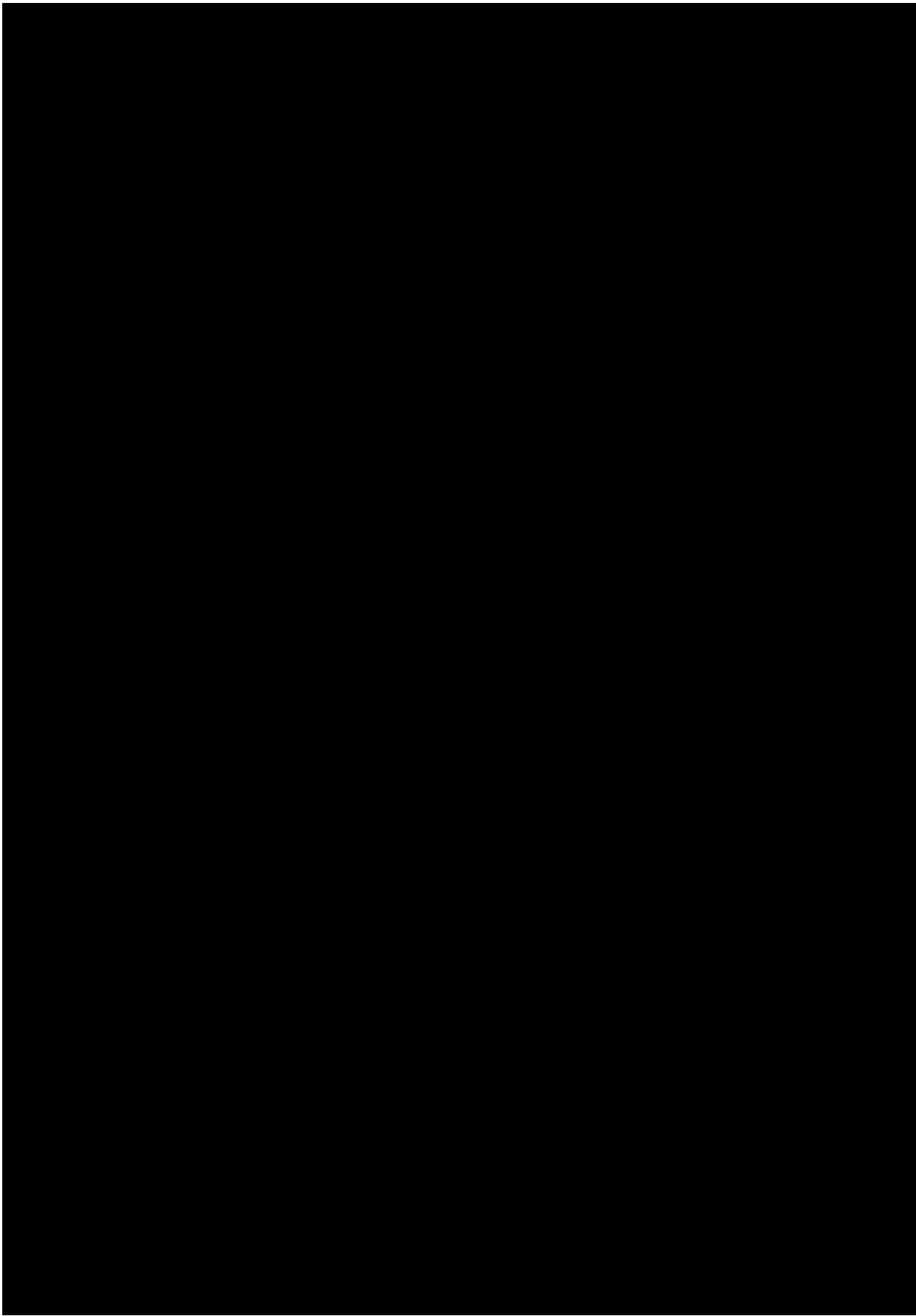

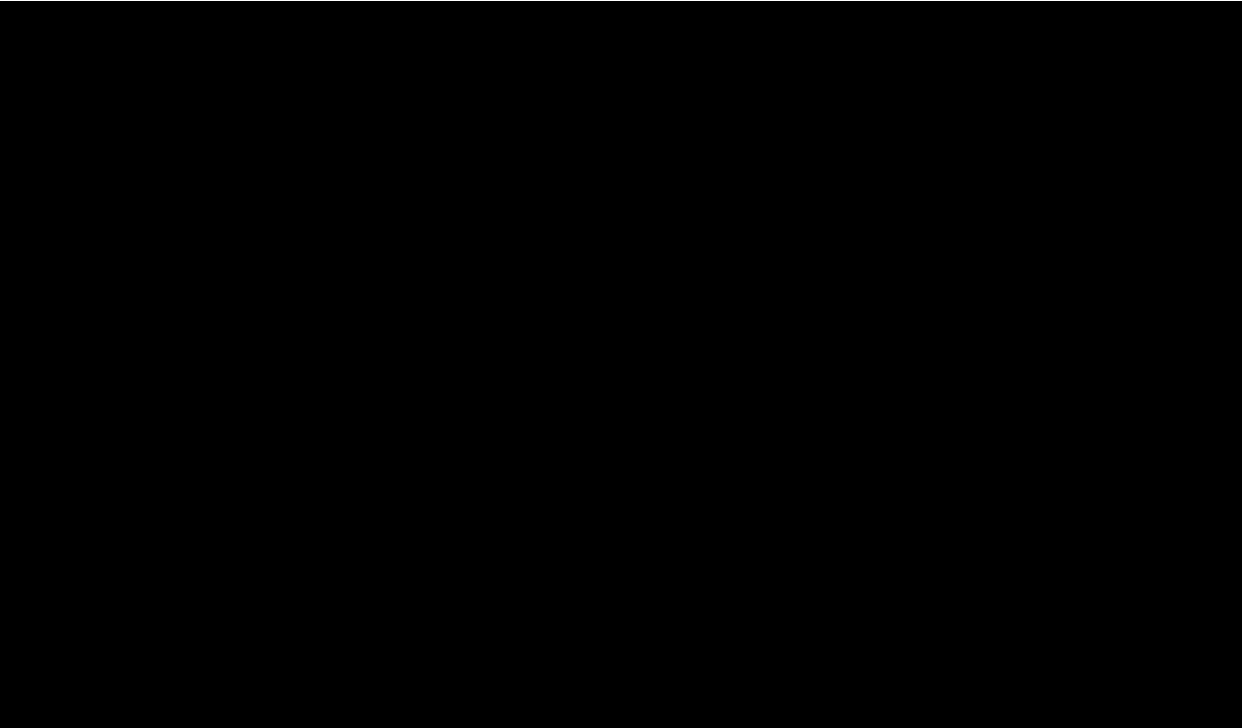

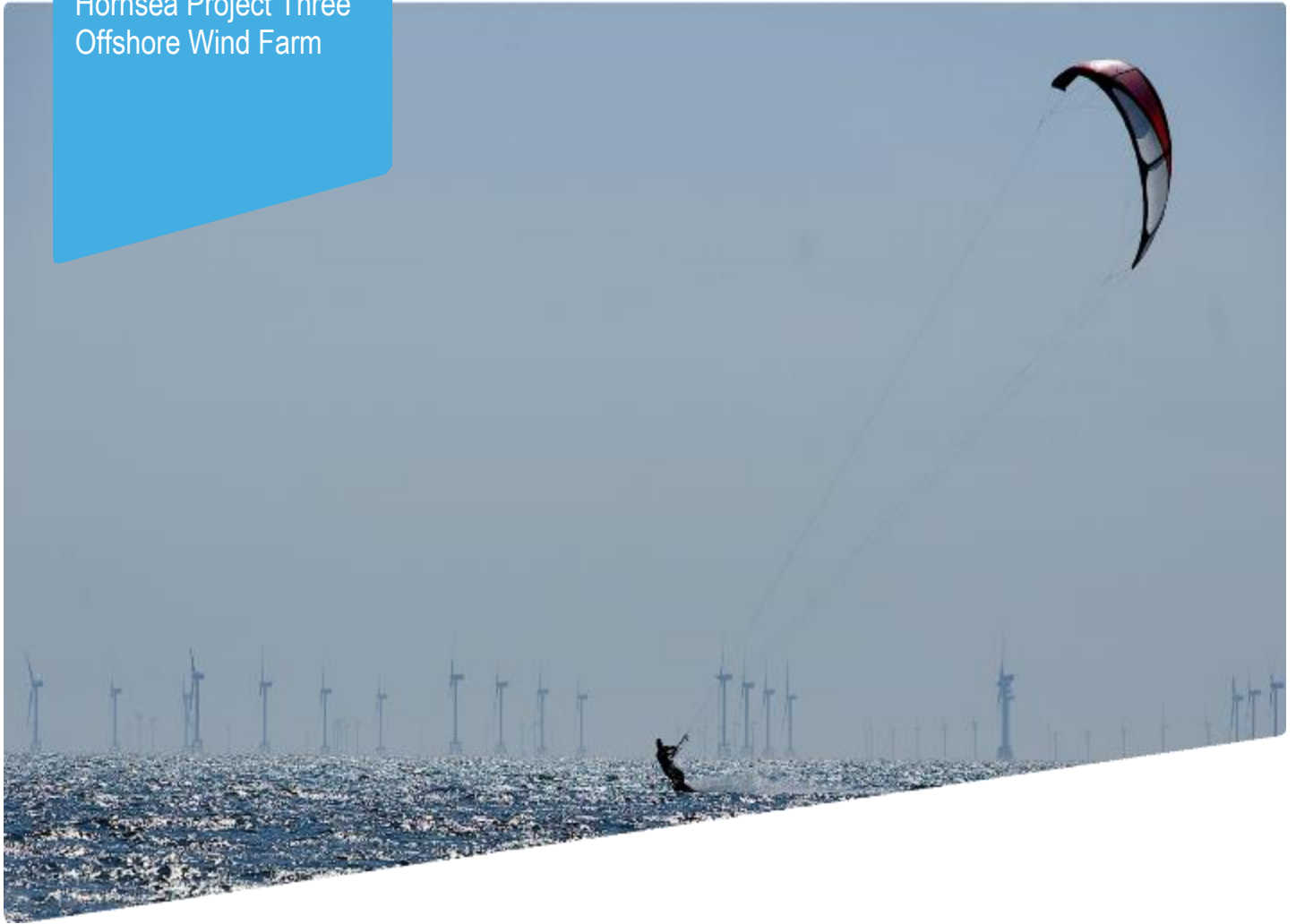

## 1. Introduction

This document provides a guide to Ørsted Hornsea Project Three Development Consent Order application. The application was submitted to the Planning Inspectorate on 14<sup>th</sup> May 2018 and accepted for examination by the Examining Authority on 11<sup>th</sup> June 2018.

Since submission and through the examination process it is anticipated that some of the original application documents, in particular “live” documents such as the Development Consent Order and Outline Code of Construction Practice will be revised, and new documents issued.

This guide charts the submission of these documents to the Planning Inspectorate through the examination process.

This is a live document and will be updated throughout the examination period and submitted, when updated, for each deadline.
