# 1 Introduction

# 1.1 Purpose of this Document

- 1.1.1 This Application Guide provides an ease of reference guide and summary of the application by Wheelabrator Technologies Inc. ("WTI") for a Development Consent Order ("DCO") relating to the K3 generating station and WKN waste-to-energy facility in Kemsley, Sittingbourne, Kent.
- 1.1.2 This document provides an accessible guide to the proposed development, applicant and application to assist those reviewing the application documents. As the examination of the DCO application progresses this document will be updated in order to record any revisions made to the original application documents and any new documents submitted during the course of the examination, together with providing explanatory notes as required.

# 2 The Proposed Development

# 2.1 Context to the DCO Application

- 1.1.1 The application for a DCO seeks consent for the construction and operation of a 75MW waste-to-energy facility, 'the Wheelabrator Kemsley Generating Station' ("K3") and for the construction and operation of a 42MW waste-to-energy facility, 'Wheelabrator Kemsley North' ("WKN").
- 1.1.2 K3 is a waste-to-energy facility located adjacent to and east of the DS Smith Kemsley paper mill, to the north of Sittingbourne, Kent. Planning permission was granted for K3 in 2012 by Kent County Council with a generating capacity of 49.9MW and a waste processing capacity of 550,000 tonnes per annum. The facility is became fully operational in Q3 2020.
- 1.1.3 The applicant has identified that K3 would be capable of processing an additional 107,000 tonnes of waste per annum and, without any change to the external design, generating an additional 25.1MW of electricity. However, in order for the K3 project to be properly categorised and consented under the Planning Act 2008 the applicant is required to seek consent for the construction of K3 at its total generating capacity of 75MW (i.e. 49.9MW consented + 25.1MW upgrade), together with the separate proposed total tonnage throughput of 657,000 tonnes per annum (550,000 consented + 107,000 tonnage increase).
- 1.1.4 The proposed new Waste-to-Energy plant, Wheelabrator Kemsley North (WKN), would be a single 125Mwth line facility capable of processing 390,000 tonnes of waste per annum, with a generating capacity of 42MW. WKN is not therefore a Nationally Significant Infrastructure Project (NSIP) by virtue of its generating capacity.
- 1.1.5 Instead WTI made a formal application on the 1st June 2018 to the Secretary of State (SoS) for Business, Energy and Industrial Strategy under Section 35 of the Planning Act 2008 for a direction as to whether the project is nationally significant. The SoS issued their direction on the 27th June 2018 confirming that WKN is to be considered and treated as a development which requires development consent due to its context with other nationally significant projects in the vicinity, the benefits to K3 and WKN being assessed comprehensively through the same DCO process and the removal of the need for separate consents to be sought.
- 1.1.6 A single Development Consent Order is being sought for K3 and WKN through a single application to the Planning Inspectorate (PINS), prior to being determined by the Secretary of State (SoS) for Business, Energy and Industrial Strategy.

### 2.2 The Site and its surroundings

2.2.1 The K3 and WKN sites lie to the north-east of the village of Kemsley, which itself sits at the north-eastern edge of Sittingbourne in Kent. The K3 and WKN

sites lie immediately to the east of the Kemsley Paper Mill, a substantial industrial complex which is operated by DS Smith.

2.2.2 In April 2018 DS Smith lodged an application for a Development Consent Order (DCO) which would allow for the construction and operation of 'K4', a gas fired Combined Heat and Power Plant within the Kemsley Mill site. This DCO was granted on 5<sup>th</sup> July 2019.

### Wheelabrator Kemsley - K3

2.2.3 Planning permission was granted for K3 in 2012 by Kent County Council under reference SW/10/444. As consented, K3 can process up to 550,000 tonnes of waste each year and has a generation capacity of 49.9MW. K3 will export electricity to the grid and will supply steam to the DS Smith Kemsley Paper Mill. As of Q2 2020 K3 is operational.

- 2.2.4 WTI has identified that K3 would be capable of processing an additional 107,000 tonnes of waste per annum and, without any change to the external design, generating an additional 25.1MW of electricity.
- 2.2.5 The 2018 consultation and publicity sought views from interested parties on an application for consent for that power upgrade and increased tonnage throughput, without any construction works being required, as an extension to the K3 facility under Section 15 of the Planning Act 2008.
- 2.2.6 However, in order for the K3 project to be properly categorised and consented under the Planning Act 2008 the applicant is now seeking consent for the construction of K3 at its total generating capacity of 75MW (49.9MW consented

- + 25.1MW upgrade), together with the separate proposed total tonnage throughput of 657,000 tonnes per annum (550,000 consented + 107,000 tonnage increase).
- 2.2.7 A further consultation was undertaken in 2019 to advise S42 consultees and notify the public through a number of S48 notices that construction and operation of K3 is now being sought as part of the DCO, in the context of the K3 facility already being constructed and operational.
- 2.2.8 As the K3 facility is currently operational the effect in reality of the DCO ('the practical effect') would be the retention of the K3 facility as consented but with it generating an additional 25.1MW together with being able to process an additional 107,000 tonnes of waste per year.

# Wheelabrator Kemsley North - WKN

- 2.2.9 WKN would be an entirely new and separate waste-to-energy facility on land to the north of K3, which is currently being used as the K3 construction laydown area. WKN would provide clean, sustainable electricity to power UK homes and businesses via the National Grid distribution network and would have the ability to export steam should a user for that steam become available.
- 2.2.10 WKN would have a generating capacity of 42MW and a waste processing capacity of 390,000 tonnes per annum and be a self-contained and fully enclosed facility with its own reception hall, waste fuel bunker, boiler, flue gas treatment, turbine, air-cooled condensers, transformers, office accommodation, weighbridge, administration building, car parking and drainage. WKN would have its own grid connection to allow for the exporting of electricity to the national grid.

## 2.3 The Draft Development Consent Order

2.3.1 The draft DCO makes provision for specific works 1 – 8 within the DCO boundary, which encompasses both the K3 and WKN sites. The DCO consists of the following works:

#### **K3** Proposed Development:

- Work No.1 An electricity generating station (the K3 Generating Station) with a gross installed generating capacity of up to 75MW.
- Work No. 1A Installation of grid connection for Work No 1.
- Work No. 1B Installation of steam connection for Work No 1.
- Work No. 1C Alteration of existing private access road to construct, use and maintain Work No 1.
- Work No. 1D Creation of a temporary construction compound and laydown area for the construction of Work No 1.

- Work No. 1E Construction and operation of a surface water outfall for Work No 1.
- 2.3.2 The K3 works reflect the full scope of works necessary for the construction and operation of K3, given development consent is being sought in those terms. In reality the works described have been completed.

#### WKN Proposed Development

- Work No.2 An electricity generating station (the WKN Waste-to-Energy Facility) with a gross installed generating capacity of up to 42MW.
- Work No.3 Installation of grid connection for Work No 2.
- **Work No. 4** Alteration of existing private access road to construct, use and maintain Work No 2.
- **Work No. 5** Temporary construction or alteration of existing private haul road for the construction of Work No 2.
- **Work No. 6** Creation of a temporary construction compound and laydown area for the construction of Work No 2.
- Work No. 7 Construction and operation of a new surface water outfall for Work No 2.



# 3 The Applicant

# 3.1 The Applicant – Wheelabrator Technologies Inc.

- 3.1.1 Wheelabrator Technologies Inc. (WTI) is the second largest US waste-to-energy business and is an industry leader in the conversion of everyday residential and business waste into clean energy. Wheelabrator currently has a platform of 25 strategically located assets across the US and UK —19 waste-to-energy facilities (three under construction), two waste fuel facilities as well as four ash monofills.
- 3.1.2 WTI also recover metals for recycling at two advanced metals recovery systems and one central upgrade facility. Wheelabrator currently has an annual waste processing capacity of over 7.2 million tonnes (8 million tonnes), and a total combined electric generating capacity of 732 megawatts enough energy to power more than 671,100 US homes. Wheelabrator also recovers metals for recycling into commercial products. The company's vision to develop, deliver and realize the potential of clean energy speaks to Wheelabrator's ongoing commitment to the development of clean energy solutions for its customers and local communities.

#### 4.2 Timeline

# (1) Submission of the DCO Application – 6<sup>th</sup> April 2019 (Volumes 1, 2, 3, 4, 5 and 6)

Submission of an application for development consent for the construction and operation of a 75MW waste-to-energy facility, 'the Wheelabrator Kemsley Generating Station' ("K3") and for the construction and operation of a 42MW waste-to-energy facility, 'Wheelabrator Kemsley North' ("WKN").

### (2) Submission following S51 Advice – 18<sup>th</sup> October 2019

The application was accepted for examination on the 8<sup>th</sup> October 2019, with the Planning Inspectorate also issuing a letter detailing advice under S51 of the Planning Act 2008 on that date. Accordingly the applicant made amendments to various documents to address that S51 advice and submitted those to the Planning Inspectorate on the 18<sup>th</sup> October 2019, ahead of the period during which Relevant Representations could be made.

# (3) Deadline 1 Submission – 2<sup>nd</sup> March 2020

The submissions by the Applicant at Deadline 1 are recorded in Volume 9 and comprise comments on Relevant Representations and other submissions accepted by the ExA between the acceptance of the application and the Preliminary Meeting, a written submission of the oral case made by the Applicant at Issue Specific Hearing 1 – the draft DCO, and suggestions by the Applicant regarding locations for the unaccompanied site visit.

# (4) Deadline 2 Submission – 18<sup>th</sup> March 2020

### 4.3 Other Matters

- 4.3.1 There is no Crown Land within the proposal site or the immediate vicinity, so no Crown Plan has been submitted.
- 4.3.2 The proposed development takes place on land which is not owned by WTI. Therefore a Book of Reference has been provided to support the application. However no compulsory acquisition rights or rights over statutory undertaker equipment are being sought. No Funding Statement or Statement of Reasons is submitted but instead a Summary of Land Interests and Rights (Document 2.5) and Summary of Applicant's Structure and Standing (Document 2.6) have been submitted.

- 6.1.1 The **Draft Development Consent Order (2.1)** provides the consent that would enable WTI to undertake the proposed development subject to the provisions and requirements of the Order. It defines the parameters of the proposed development and is accompanied by four schedules:
  - (1) Schedule 1 Authorised Development: Describes the proposed development for which consent is being sought;
  - (2) Schedule 2
    - Part 1 General Requirements: Similar to planning conditions, both the K3 and WKN proposed development must be carried out in accordance with the requirements;
    - Part 2 Project K3 Requirements: sets out that the K3 proposed development must be carried out in accordance with the requirements;
    - Part 3 Project WKN Requirements: sets out that the WKN proposed development must be carried out in accordance with the requirements;

- (3) Schedule 3 K3 Generating Station Approved Plans and Documents: Any documents and plans submitted as part of the original K3 application, or subsequent applications to vary the original consent, make non-material amendments to the scheme or to discharge conditions have been submitted as part of the application to become certified documents.
- (4) Schedule 4 Procedure for Discharge of Requirements: sets out the process for discharging the requirements should the development consent order be granted.
- 6.1.2 The **Explanatory Memorandum** (2.2) is effectively a companion guide for the DCO and should be read alongside it. This document describes the purpose and effect of each article of and each Schedule to the draft Development Consent Order as required by Regulation 5(2)(c) of the Infrastructure Planning (Applications: Prescribed Forms and Procedure) Regulations 2009.
- 6.1.3 The **Draft Development Consent Order Validation Report (2.3)** demonstrates that the draft DCO is in compliance with the Statutory Instrument template and capable of becoming a legal document.
- 6.1.4 The application was originally accompanied by a Statement of Reasons (2.5) and Funding Statement (2.6). As part of the S51 Submission those documents have been resubmitted but are retitled to now be the **Summary of Land Interests and Rights (2.5)** and the **Applicant's Structure and Standing (2.6)** to avoid any confusion given no compulsory acquisition rights are sought.
- 6.1.5 The Table of Amendments to the draft Development Consent Order (2.7) is a new document submitted at Deadline 2 and revised at Deadline 4 which tabulates the changes made at each Deadline to the previous version of the dDCO.
- 6.1.6 The **K3 Book of Reference (2.8)** is a new document submitted at Deadline 7 which reflects the production by the ExA of a K3 only DCO, and which therefore reflects the land associated with just the K3 element of the DCO land.

#### 7.5 Addendums to the March 2010 ES

7.5.1 Following the approval of the original consent for K3 application a number of non-material amendments and variations were made resulting in three separate addendums to the March 2010 ES.

## ES Addendum (Air Quality) (June 2013)

7.5.2 A non-material amendment to the site layout was consented on the 2<sup>nd</sup> September 2013 under reference SW/10/444/R. An ES Addendum relating to air quality was submitted as part of that application to remodel the release of emissions from the stack, given the stack location had changed. That Addendum therefore now forms part of the ES and accordingly has been included.

## ES Chapter 10 - Hydrology and Flood Risk (May 2017)

7.5.3 An application was made under reference SW/17/502996 to vary Condition 16 of the original planning permission, which was approved on the 23<sup>rd</sup> August 2017. Condition 16 relates to drainage, with the application proposing an alternative drainage management regime for the K3 development. The application included an ES Addendum relating to Hydrology and Flood Risk which assessed the impacts of the change in EIA terms and included as an appendix the December 2016 version of the Surface Water Management and Foul Drainage Design Philosophy Statement, which is also separately listed within Schedule 3. As the Addendum forms part of the ES it has been included within Schedule 3.

7.5.4 A further variation was approved on the 11<sup>th</sup> October 2018 under reference SW/18/503317. Condition 3 of the K3 planning permission was varied to increase the number of HGV movements permitted for the K3 facility to result in the 348 movements currently consented. An ES Addendum was included with that application and includes an assessment of the transport and air quality implications of that change. As such it forms part of the ES and is therefore listed within Schedule 3.

Under Sections 42, 47 and 48 of the Planning Act 2008 an applicant is required to publicise an application for a DCO and to consult the local community, specifically prescribed bodies and local authorities. The Consultation Report sets out how the applicant has responded to the consultation responses received prior to the application being made.
- 8.1.2 In 2017, the applicant consulted on an application to increase the maximum gross electrical power output of the existing consented Kemsley K3 Generating Station, from 49.9 Megawatts electrical (MW) to up to 75 MW. This is referred to as the '2017 consultation'.



- 8.1.3 However the scope of the proposed application then changed to instead comprise an application to increase the generating capacity and the tonnage throughput of the Wheelabrator Kemsley Generating Station (K3), as an extension to that facility, and for the construction and operation of a new 42MW waste-to-energy facility, 'Wheelabrator Kemsley North' (WKN).
- 8.1.4 S47 consultation in those terms took place in October and November 2018, followed by S42 consultation and S48 publicity concurrently during December 2018 and early January 2019. Prior to the formal consultation exercise some informal non-statutory consultation had taken place with Swale Borough Council and selected statutory bodies in order to inform the preparation of the SoCC and continued during the formal consultation process alongside S47 to engage with local politicians and residents where appropriate. This is referred to as the '2018 consultation'.
- 8.1.5 In July and August 2019 the applicant undertook a re-consultation to clarify that consent is being sought in respect of K3 for the construction of a 75MW generating station, in circumstances where that generating station has already been constructed as a 49.9MW generating station under planning permission granted under the Town & Country Planning Act 1990. This re-consultation included consultation with S42 consultees and additional S48 publicity. This is referred to as the '2019 consultation'.
- 8.1.6 The Consultation Report is set out as follows:

- 8.1.7 The **Consultation Report** is accompanied by appendices which supports the document and illustrates the materials on which the pre-application consultation was based. It also provides a record of the correspondence with the required parties and local community including copies of published notices and statutory consultations.



# 8.2 Planning Statement

- 8.2.1 **Document 4.2 Planning Statement** assesses the compliance of the proposed development with the policy set out within the relevant National Policy Statements (NPS's) and discusses other relevant and important national and local planning policy and any other factors which would constitute other relevant and important matters under S104 or S105 of the Planning Act 2008.
- 8.2.2 This **Planning Statement** should be read alongside the other documents which form the DCO application, and in particular:
  - The Application Guide (Document 1.2);
  - The draft Development Consent Order and its Explanatory Memorandum (Documents 2.1 and 2.2);
  - The Environmental Statement and Non-Technical Summary (Documents 3.1 and 3.2);
  - The Consultation Report (Document 4.1);
  - The Design and Access Statement (Document 4.3).

# 8.3 Design and Access Statement

- 8.3.1 **Document 4.2 The Design and Access Statement** forms a self-contained summary of the proposed scheme in its entirety. It forms part of the application for the proposed DCO and describes the proposal site and its surrounding context and explains the rationale behind the siting, design and access arrangements of the proposed scheme. The Design and Access Statement should be read in conjunction with:
  - The Application Guide (Document 1.2);
  - The Environmental Statement and Non-Technical Summary (Documents 3.1 and 3.2);
  - The Consultation Report (Document 4.1);
  - The Planning Statement (Document 4.2).

## 8.4 Statement of Statutory Nuisances

8.4.1 The **Statement of Statutory Nuisances (Document 4.4)** sets out whether the development proposal could cause a statutory nuisance pursuant to Section 79(1) of the Environmental Protection Act 1990 (EPA) and if so, how the applicant proposes to mitigate or limit them.

# 8.5 Regulation 6 - Grid Connection Statement

8.5.1 The **Regulation 6 - Grid Connection Statement (Document 4.5)** sets out who will be responsible for designing and building the connection to the electricity grid. This Statement should be read in conjunction with the Environmental Statements and NTS' and Design and Access Statement which accompany the DCO application.

## 8.6 Waste Hierarchy and Fuel Availability Report

- 8.6.1 The National Policy Statement EN-3 requires an assessment of the proposed waste combustion generating station (i.e. K3 and WKN) to be undertaken that examines the conformity of the developments with the waste hierarchy and the effect of the scheme on the relevant waste plan or plans where a proposal is likely to involve more than one local authority. The Waste Hierarchy and Fuel Availability Report (Document 4.6) is a separate document which demonstrates how K3/WKN conforms both to the waste hierarchy and relevant waste plans and strategies.
- 8.6.2 This report should be read in conjunction with the Planning Statement.

# 8.7 Combined Heat and Power (CHP) Assessment

8.7.1 The purpose of **CHP Assessment (Document 4.7)** is to demonstrate the CHP opportunity, benefits and feasibility of supplying heat from the proposed developments to local heat consumers. This report responds to Section 4.6 of NPS EN-1 which requires applications for thermal generating stations, such as the proposed K3 and WKN developments, to consider CHP.



## 8.8 K3 Rail and Water Transportation Strategy

8.8.1 The **K3 Rail and Water Transportation Strategy (Document 4.8)** examines the potential for waste to be transported to the proposed development via the rail network or via water as oppose to via road.

### 8.9 WKN Rail and Water Transportation Strategy

8.9.1 The WKN Rail and Water Transportation Strategy (Document 4.9) examines the potential for waste to be transported to the proposed development via the rail network or via water as oppose to via road.

# 8.10 WKN Ecological Mitigation and Management Plan

8.10.1 The WKN Ecological Mitigation and Management Plan (Document 4.10) has been prepared in line with Requirement 21 of the draft DCO to demonstrate that the ecological impacts arising from the proposed development of WKN can be addressed and mitigated.

#### 8.11 WKN Draft CTMP

8.11.1 The WKN Draft CTMP provides the details of how the construction traffic will be managed. The submission includes the Applicant's Preferred Version of the WKN Draft CTMP (Document 4.11) and the Highways England's Preferred Version of the WKN Draft CTMP (Document 4.12). A final version of the WKN Draft CTMP will replace Appendix 4.1 of the ES (Document 3.1 – REP5-003).

#### 8.12 K3 and WKN Draft Travel Plans

8.12.1 The K3 Draft Travel Plan provides the details of how the operational traffic related to K3, such as HGV movements and staff travel to work, will be managed. The submission includes the Applicant's Preferred Version of the K3 Draft Travel Plan (Document 4.13) and the Highways England's Preferred Version of the K3 Draft Travel Plan (Document 4.14) which reflect ongoing discussions between the Applicant and Highways England at Deadline 8.

- 9.1.1 Documents 5.1 Site Location Plan shows the location of the proposed development within the local context. The DCO Site Boundary Plan (Document 5.2) and DCO Site Boundary Plan Aerial (Document 5.3) shows the DCO boundary; the land to which the DCO would relate. Document 5.4 Land Plan shows the land that is to be affected by the DCO.
- 9.1.2 **Document 5.5a K3 Works Plan** shows the extent of the works necessary for the construction and operation of K3, given development consent is being sought in those terms. In reality the works described have either been completed or substantially completed at the point of the application being submitted and are expected to be completed by the end of 2019. These works are as follows:

- Work No.1 An electricity generating station (the K3 Generating Station) with a gross installed generating capacity of up to 75MW.
- Work No. 1A Installation of grid connection for Work No 1.
- Work No. 1B Installation of steam connection for Work No 1.
- Work No. 1C Alteration of existing private access road to construct, use and maintain Work No 1.
- Work No. 1D Creation of a temporary construction compound and laydown area for the construction of Work No 1.
- Work No. 1E Construction and operation of a surface water outfall for Work No 1.
- 9.1.3 **Document 5.5b WKN Works Plan** shows the extent of the works necessary for the construction and operation of WKN, as follows:
  - Work No.2 An electricity generating station (the WKN Waste-to-Energy Facility) with a gross installed generating capacity of up to 42MW.
  - Work No.3 Installation of grid connection for Work No 2.
  - Work No. 4 Alteration of existing private access road to construct, use and maintain Work No 2.
  - Work No. 5 Temporary construction or alteration of existing private haul road for the construction of Work No 2.
  - Work No. 6 Creation of a temporary construction compound and laydown area for the construction of Work No 2.
  - Work No. 7 Construction and operation of a new surface water outfall for Work No 2.
- 9.1.4 The WKN Parameter Plans (Document 5.6) sets out the limits for the construction of the buildings and infrastructure as part of WKN. It is not possible to construction WKN to the maximum parameters but allows for flexibility in the final design stage. The WKN Illustrative Layout Plan (Document 5.7) and WKN Illustrative Elevations (Document 5.8) provides an indicative

- view of the WKN as constructed and the K3 and WKN Illustrative CGI (Document 5.10) sets out the proposed views of both K3 and WKN as constructed.
- 9.1.5 The **K3 and WKN Connection and Tie-In Plan (Document 5.9)** sets out how the proposed developments will connect with the local infrastructure such as delivery of steam to the adjacent paper mill and the electricity grid.
- 9.1.6 **Document 5.11 Nature Conservation Designations Plan** identifies the site in relation to environmental designations within the wider area. This includes Air Quality Management Areas, Special Protection Areas and RAMSAR sites, Sites of Special Scientific Interest (SSSI), Local Wildlife Sites and Flood Zones 2 and 3. **Document 5.12 Habitats Plan** identifies the site in relation to biodiversity designations such as priority habitats, habitats and species records.
- 9.1.7 **Document 5.13 Water bodies Plan** identifies the site in relation to local water bodies. **Document 5.14 Heritage and Conservation Designations** Plan identifies the site in relation to heritage assets which are Listed Buildings, Conservation Areas and Scheduled Monuments.
- 9.1.8 Document 5.15 ExA's K3 Alternative DCO Land Plan and Document 5.16 ExA's K3 Alternative DCO K3 Works Plan have been submitted at the request of the ExA at Deadline 7 to provide appropriate plans should only the K3 proposed development be recommended for development consent.
