Examining Authority's Note of Unaccompanied Site Inspection on 30 June and 1 July 2020

Background

As Examining Authority (ExA) I undertook an Unaccompanied Site Inspection to support my examination of the above-mentioned application for development consent on 30 June and 1 July 2020.

Routes for inspections were planned having regard to issues raised during the Examination and were undertaken from publicly accessible land including highways and public rights of way. No access to private land including the application site was sought and so I was able to undertake the inspection on an unaccompanied basis.

I undertook the inspection alone. I did not encounter any interested parties or other persons during my inspection. Weather conditions were changeable which slowed progress and caused me to vary my planned itinerary, however all inspections were eventually made under conditions of clear visibility. My inspection was undertaken by car and on foot. Visits to the highways network at locations the subject of representations from interested parties, were made during the peak hours period in the evening of 30 June and in the morning of 1 July.
