

Norfolk Boreas Project:

Examining Authority's record of unaccompanied site inspections up to 15 November 2019 (amended)

Application by Vattenfall for an Order granting development consent for the Norfolk Boreas project (the Application)

Examining Authority's record of unaccompanied site inspections to which the application or specified matters relate

The Panel appointed as the Examining Authority for the Norfolk Boreas project undertook unaccompanied site inspections (USIs) as listed below.

The USIs were undertaken on foot and by car, on public roads and footpaths. Routes for visits were planned having regard to issues raised from relevant representations enabling the Panel to obtain views of the proposals. Regard was also given to the verified viewpoints (VP) contained in the Environmental Statement (ES).

Where specific places not identifiable by name are referenced, the references are taken from the Policies and Designations drawings [APP-430] and the Public Rights of Way, cycle routes and long-distance trails maps [APP-535]. The reference number in format 'VP**' has been provided for the VPs contained in the ES [APP-509] to [APP-532], and in format 'CH*' the Heritage settings assessment [APP-672].

This list of sites inspected will be updated as further USIs are undertaken by Panel members over the course of its examination of the Application.
