APPLICATION FOR A NON-MATERIAL CHANGE ORDER IN RESPECT OF A MINOR ADDITION TO THE ORDER LIMITS AND ASSOCIATED CHANGES TO SCHEDULE 11 ‘DOCUMENTS AND PLANS TO BE CERTIFIED’

THE IMMINGHAM OPEN CYCLE GAS TURBINE (VPI ‘B’) PROJECT, LAND NORTH OF THE VPI COMBINED HEAT AND POWER (‘CHP’) POWER STATION, ROSPER ROAD, IMMINGHAM, LINCOLNSHIRE, DN40 3DZ

We write on behalf of VPI Immingham B Limited (the ‘Applicant’ and ‘Undertaker’) following the submission of an application for a non-material change order (the ‘Application’) to ‘The Immingham Open Cycle Gas Turbine Order 2020’ (S.I. 2020 No. 847) (the ‘Development Consent Order’ or ‘DCO’) pursuant to Section 153 of ‘The Planning Act 2008’ (the ‘PA 2008’) and Regulation 4 of ‘The Infrastructure Planning (Changes to, and Revocation of, Development Consent Orders) Regulations 2011’ (the ‘2011 Regulations’), to the Secretary of State for Energy Security and Net Zero (‘DESNZ’) on 4th March 2025.

This letter and its attachments constitute the Applicant’s ‘Consultation and publicity statement’ in connection with the non-material change application, as required by Regulation 7A of the 2011 Regulations.

The Applicant can confirm the following:

- The Application Documents and the notice publicising the Application pursuant to Regulation 6 of the 2011 Regulations were published on the project website in advance of the publication of the Regulation 6 notice and issue of the consultee letters.
- The Regulation 6 notices providing detail of the non-material change application has been published for two consecutive weeks in both the Grimsby Telegraph and the Scunthorpe



Telegraph on the 6th and 13th March 2025. The notices comply with the requirements of Regulation 6 of the 2011 Regulations.

- Letters enclosing a copy of the Regulation 6 notice were sent to the relevant consultees on 5th March and 12th March 2025 providing information on the Application, details of how the Application Documents can be inspected, how to submit comments and the deadline for doing so. The consultation was in accordance with Regulation 7(1) of the 2011 Regulations. The letters included a link to both the project website and the PINS project page from which all of the Application Documents could be downloaded.
- In accordance with Regulation 7(3) of the 2011 Regulations, it was agreed with DESNZ that the Applicant need not consult all of the persons or authorities specified in Regulation 7(2).

As noted above, a second consultation letter (and updated copy of the Regulation 6 notice) was sent to the agreed consultee list on 12th March 2025. The letter and updated notice made consultees aware of an extension in the period for comment by 1 week.
