An application has been submitted under paragraph 2 of Schedule 6 to the Planning Act 2008<sup>(a)</sup> to the Secretary of State in accordance with the Infrastructure Planning (Changes to, and Revocation of, Development Consent Orders) Regulations 2011<sup>(b)</sup> for a non-material change to The Little Crow Solar Park Order 2022 <sup>(c)</sup>.

The Secretary of State, having considered the responses to the publicity and consultation carried out in accordance with regulations 6 and 7 of the Infrastructure Planning (Changes to, and Revocation of, Development Consent Orders) Regulations 2011, has decided to make this Order amending The Little Crow Solar Park Order 2022.

## **Amendment of The Little Crow Solar Park Order 2022**

2.—(1) The Little Crow Solar Park Order 2022 (“the Original 2022 Order”) is amended by this Order as follows—

(2) In Schedule 2 part 1 paragraph (1) of requirement 3 shall be deleted and replaced as follows—

“3 – (1) The authorised development must cease generating electricity on a commercial basis no later than the 45<sup>th</sup> anniversary of the first export date from Work No.1.

(3) In Schedule 2 part 1 paragraph (1) of requirement 4 shall be deleted and replaced as follows—

“4-(1) Not less than 6 months before the 45<sup>th</sup> anniversary of the first export date, a decommissioning and site restoration scheme must be submitted to the local planning authority for its approval. The decommissioning and site restoration schemes(s) must be accordance with the outline decommissioning strategy.
