The Net Zero Teesside (Correction) Order 2024

Made - - - - 20th December 2024

Coming into force - - 21st December 2024

The Net Zero Teesside Order 2024(a) ("the 2024 Order") which granted development consent within the meaning of the Planning Act 2008(b) ("the Act") contains correctable errors within the meaning of paragraph 1 of Schedule 4 to the Act.

In accordance with paragraph 1(5)(a) of Schedule 4 to the Act, before the end of the relevant period (as defined in paragraph 1(6)(a) of Schedule 4 to the Act), the Secretary of State received a written request from the applicant(\mathbf{c}) for the correction of errors and omissions in the 2024 Order.

In accordance with paragraph 1(7) of Schedule 4 to the Act, the Secretary of State has informed Redcar and Cleveland Borough Council and Stockton-on-Tees Borough Council as the relevant planning authorities(**d**), that the request has been received.

The Secretary of State, in exercise of the powers conferred by section 119, and paragraphs 1(4) and 1(8) of Schedule 4 to the Act, makes the following Order.

Citation and commencement

1. This Order may be cited as the Net Zero Teesside (Correction) Order 2024 and comes into force on 21st December 2024.
