**The Net Zero Teesside (Correction) Order 2024**

*Made* - - - - *20th December 2024*

*Coming into force* - - *21st December 2024*

The Net Zero Teesside Order 2024<sup>(a)</sup> (“the 2024 Order”) which granted development consent within the meaning of the Planning Act 2008<sup>(b)</sup> (“the Act”) contains correctable errors within the meaning of paragraph 1 of Schedule 4 to the Act.

In accordance with paragraph 1(5)(a) of Schedule 4 to the Act, before the end of the relevant period (as defined in paragraph 1(6)(a) of Schedule 4 to the Act), the Secretary of State received a written request from the applicant<sup>(c)</sup> for the correction of errors and omissions in the 2024 Order.

In accordance with paragraph 1(7) of Schedule 4 to the Act, the Secretary of State has informed Redcar and Cleveland Borough Council and Stockton-on-Tees Borough Council as the relevant planning authorities<sup>(d)</sup>, that the request has been received.

The Secretary of State, in exercise of the powers conferred by section 119, and paragraphs 1(4) and 1(8) of Schedule 4 to the Act, makes the following Order.

**Citation and commencement**

1. This Order may be cited as the Net Zero Teesside (Correction) Order 2024 and comes into force on 21st December 2024.

**Corrections**

2. The 2024 Order is corrected as set out in the table in the Schedule to this Order, where—
- (a) column 1 sets out where the correction is to be made;
  - (b) column 2 sets out how the correction is to be made; and
  - (c) column 3 sets out the text to be substituted, inserted or omitted.
