### 1 Introduction

#### 1.1 Overview of the Scheme

- 1.1.1 This Statement of Commonality has been prepared in respect of the application for the proposed Sunnica Energy Farm Development Consent Order ("the Application") made by Sunnica Limited ("Sunnica") to the Secretary of State for the Department for Business, Energy and Industrial Strategy ("Secretary of State") for a Development Consent Order ("the Order") under section 37 of the Planning Act 2008 ("PA 2008").
- 1.1.2 The Order, if granted, would authorise Sunnica to construct, operate (including maintain) and decommission a ground mounted solar farm across Sunnica East Site A, Sunnica East Site B, Sunnica West Site A and Sunnica West B. The Scheme includes the following key components:
  - a. Solar PV modules;
  - b. PV module mounting structures;
  - c. Inverters;
  - d. Transformers;
  - e. Switchgear;
  - f. Onsite cabling (including high and low voltage cabling);
  - g. One or more BESS (expected to be formed of lithium ion batteries storing electrical energy) on Sunnica East Site A, Sunnica East Site B, and Sunnica West Site A;
  - An electrical compound comprising a substation and control building (Sunnica East Site A, Sunnica East Site B, and Sunnica West Site A only);
  - Burwell National Grid Substation Extension should Burwell National Grid Substation Extension Option 2 be taken forward;
  - j. Office/warehouse (Sunnica East Site A and Sunnica East Site B only);
  - k. Fencing and security measures;
  - Drainage;
  - m. Internal access roads and car parking;
  - n. Landscaping including habitat creation areas; and
  - o. Construction laydown areas.



#### 1.2 Purpose of the Statement of Commonality

1.2.1 This document provides the Examining Authority (ExA) with an update on the position of each Statement of Common Ground (SoCG) between the Applicant and the interested parties in relation to the Scheme at Deadline 4. This document has been updated since Deadline 2 and will continue to be updated and submitted at the requested deadlines outlined in the Examination timetable for the Scheme.

## 3 Additional Commentary

#### 3.1 Deadline 2

- 3.1.1 Since issue by the ExA of the letters dated 28 June and 31 August 2022:
  - a. A joint SoCG has been prepared for Cambridgeshire County Council, Suffolk County Council, East Cambridgeshire District Council and West Suffolk Council in line with the joint meetings with the Local Planning Authorities.
  - b. Natural England and Suffolk Wildlife Trust both agreed to enter into separate SoCGs with the Applicant.
  - c. The Newmarket Horsemen Group agreed to enter into a joint SoCG with the Say No To Sunnica Action Group (SNTS).
  - d. RSPB contacted the Applicant and raised that they were not registered as Interested Parties to the Examination so would not be able to act as signatories to an SoCG.
  - e. National Grid SoCG has been split into separate SoCGs for National Grid Electricity Transmission plc and National Grid Gas plc.
  - f. A number of other parties have come forward requesting input to SoCGs including: Isleham Parish Council, Reach Parish Council, Anglian Water, Kennet Parish Council, Barton Mills Parish Council, Wicken Parish Council, West Row Parish Council and Newmarket Town Council.
