Update following ISH3

Further to paragraph 4.2.12 of the Written Summary of Applicant's Oral Submissions at the Issue Specific Hearing 3 (ISH3) on 8 December 2022 [REP4-032], and following correspondence between Lichfields (acting on behalf of the Applicant) and Mr Sykes Popham (acting on behalf of SNTS), it has been agreed that the Hatchfield farm decision in full is relevant, within which the ExA should focus its attention on the following agreed paragraphs:

- 1. IR31-38, IR100-113, IR147-160, and IR294-323, which set out the positions of the appeal parties;
- 2. IR 398-437, IR438-487, and IR502-540, which relate to the Inspectors' conclusions regarding highways, the horseracing industry (HRI) and the overall planning balance; and
- 3. 16-22 of the SoS Decision letter.

The Applicant is of the view that the most important of the agreed paragraphs listed above are the Inspectors' conclusions on the HRI issue – paragraphs IR438 to 487 – as referenced in Paragraph 16 of the SoS decision letter.
