- 1.1 The Schedule of Changes to the draft DCO submitted at Deadline 6 is set out below.
- 1.2 The Applicant intends to make further amendments to the draft DCO that are not included in the version submitted at Deadline 6, including:
- 1.2.1 the Applicant is engaging with the Councils on the detail for the fee schedule to be included in Schedule 13 and will update the draft DCO once it has been agreed; and
- 1.2.2 if required, protective provisions for the protection of highways infrastructure will be included in the draft DCO if the Applicant and the relevant highways authorities do not enter into a legal agreement.
