The Sunnica Energy Farm (Correction) Order 2024

Made - - - - *12th November 2024*

Coming into force - - *13th November 2024*

The Sunnica Energy Farm Order 2024^(a) (“the Order”), which granted development consent within the meaning of the Planning Act 2008^(b) (“the Act”), contains correctable errors within the meaning of paragraph 1 of Schedule 4 to the Act.

In accordance with paragraph 1(5)(a) of Schedule 4 to the Act, before the end of the relevant period (as defined in paragraph 1(6)(a) of Schedule 4 to the Act), the Secretary of State received a written request from the applicant^(c) for the correction of errors in the Order.

In accordance with paragraph 1(7) of Schedule 4 to the Act, the Secretary of State has informed East Cambridgeshire District Council and West Suffolk Council as the relevant local planning authorities^(d), that the request has been received.

The Secretary of State, in exercise of the powers conferred by paragraphs 1(4) and 1(8) of Schedule 4 to the Act, makes the following Order—

Citation and commencement

1. This Order may be cited as the Sunnica Energy Farm (Correction) Order 2024 and comes into force on 13th November 2024.

Corrections

2. The Sunnica Energy Farm Order 2024 is corrected as set out in the table in the Schedule to the Order, in which—

- (a) column 1 sets out where the correction is to be made;
- (b) column 2 sets out how the correction is to be made; and
- (c) column 3 sets out the text which is to be substituted, inserted or omitted.

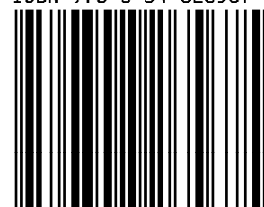
