## 1. INTRODUCTION

#### 1.1 Introduction

- 1.1.1 This document has been prepared to accompany an application by Five Estuaries Offshore Windfarm Limited ('the Applicant') for a Development Consent Order (DCO) under section 37 of the Planning Act 2008 for a new offshore windfarm 'Five Estuaries Offshore Windfarm' with an output in excess of 100MW.
- 1.1.2 The Project is a proposed extension project to the operational Galloper Offshore Wind Farm (Galloper) situated off the coast of Suffolk. The Project includes provision for the construction, operation, maintenance and decommissioning of an offshore wind farm located approximately 37 kilometres off the coast of Suffolk at its closest point in the southern North Sea; including up to 79 wind turbine generators and associated infrastructure making landfall at Sandy Point between Frinton-on-Sea and Holland-on-Sea, the installation of underground cables, and the construction of an electrical substation and associated infrastructure to the west of Little Bromley to connect the development to National Grid's proposed East Anglia Connection Node substation.
- 1.1.3 As the Project has a proposed generating capacity in excess of 100MW, it is a Nationally Significant Infrastructure Project under section 15(3) of the Planning Act 2008 ('the Act'). It therefore requires an application for a DCO to be submitted to the Planning Inspectorate under the Act.

#### 1.2 Purpose of this document

- 1.2.1 This document provides a full list of all documents submitted with the Application. This includes the revisions numbers for each document and will be updated to include the Examination Library reference when available.
- 1.2.2 These documents are set out in Appendix 1
- 1.2.3 This is intended to be a live document and Appendix 1 will be updated whenever new documents or revisions are submitted after acceptance of the DCO application and during the examination period. The table will list the latest revision of each document and highlight when a new document was submitted.
- 1.2.4 This Guide to the Application provides an overview of the contents of the Application for the Five Estuaries DCO and signposts to the documents submitted to the Secretary of State (via the Planning Inspectorate), so that information can be easily found.
- 1.2.5 In addition, Appendix 2 contains a glossary of terms and common acronyms used throughout the DCO application.
