Further to the Rule 8 letter issued by the Examining Authority (ExA) on 25 September 2024 [PD-009], we (as the Applicant) have submitted the documents listed below for the ExA's attention for Deadline 7.

The SI template validation report to support the Draft Development Consent Order has not been submitted at this deadline. Due to amends being made to the drafting of protective provisions right up until the deadline in order to reach as much agreement as possible, there was insufficient time available to validate the dDCO for Deadline 7.
