# 1. Introduction

## Purpose of this document

This document provides a guide (Guide) to the Application for a Development Consent Order (DCO) for Longfield Solar Farm. The Application is made by Longfield Solar Energy Farm Limited (the Applicant) to the Secretary of State for Business, Energy and Industrial Strategy (the Secretary of State) pursuant to the Planning Act 2008 (PA 2008).

The Applicant is seeking a DCO for the construction, operation (including maintenance), and decommissioning of ground mounted solar photovoltaic (PV) panel arrays, a Battery Energy Storage System (BESS) and supporting infrastructure (the Scheme). The Application is required because the Scheme is classified as a Nationally Significant Infrastructure Project (NSIP) under the PA 2008.

This Guide aims to help the Examining Authority (ExA) and Interested Parties understand the Application through signposting to the documents that make up the Application. This Guide has been updated iteratively, both to capture the latest versions of updated documents and to record new documents submitted as part of the Examination.

Regulation 5 of the Infrastructure Planning (Applications: Prescribed Forms and Procedure) Regulations 2009 (as amended) (APFP Regulations)) sets out the documents that all DCO applications must include. It also provides in Regulation 5(2)(q) for the submission of 'any other documents considered necessary to support the application' as well as at Regulation 5(2)(o) for '*any other plans, drawings and sections necessary to describe the proposals*'.

Regulation 6 of the APFP Regulations sets out the specific documentation required in support of DCO applications for particular types of development, including generating stations and grid connections.

The Scheme constitutes Environmental Impact Assessment (EIA) development and therefore the Infrastructure Planning (Environmental Impact Assessment) Regulations 2017 (the EIA Regulations) and requirements contained therein apply.

This Guide provides an overview of the documents that have been submitted in order to satisfy the APFP Regulations, the EIA Regulations and section 37 of the PA 2008.

## The Applicant

The Applicant, Longfield Solar Energy Farm Ltd, is a joint venture formed by two industry specialists: EDF Energy Renewables Limited (EDFR) and Padero Solar Limited (Padero).

EDFR (and the wider EDF group) has more than 25 years' worth of experience in delivering renewable energy projects in more than 20 countries around the world. In the UK, it provides much needed new affordable low carbon energy through 36 wind farms and one of the UK's largest battery storage units (together totalling almost 1GW). It also has a portfolio of rooftop solar and grid scale solar energy generation in development.

Padero has helped to develop more than 25 Solar Farms in the UK, and this has delivered over 390MWs of renewable energy. Padero Solar is part of a group of three companies. These include PS Renewables, who are behind a number of solar projects, including Eveley Solar Farm (Hampshire) and PSH Operations, an Operations & Maintenance business managing over 1.3GWs of Solar Farm assets in the UK.

## 2. The Scheme

### Scheme Description

Longfield Solar Farm is a proposed solar farm which will generate renewable energy for exporting to the National Grid (the Scheme).

It will comprise the construction, operation, maintenance and decommissioning of a solar photovoltaic (PV) electricity generating facility and Battery Energy Storage System with a total capacity exceeding 50MW. The Scheme will have an export connection to the National Grid and it also includes upgrades, modifications and an extension to the existing substation at Bulls Lodge. A detailed description of the Scheme is included in **Environmental Statement Chapter 2: The Scheme [EN010118/APP/6.1(A)]**.

At the end of its operational life the Solar Farm will undergo decommissioning. All PV modules, mounting poles, cabling, inverters and transformers would be removed. The Bulls Lodge Substation Extension will be retained and the buried Grid Connection cable will be left in-situ following decommissioning of the solar farm.

### Order Limits

The Order limits set out in the **Location Plan [EN010118/APP/2.5]** comprise approximately 453 hectares (ha) of land located within the administrative areas of Chelmsford City Council (CCC) and Braintree District Council (BDC). The Order limits are located within the county of Essex, under the jurisdiction of Essex County Council (ECC), and comprise the Solar Farm Site in which the electricity generating and storage infrastructure will be constructed, the Bulls Lodge Substation Site where the extension to Bulls Lodge Substation will be constructed and a corridor of land that comprises the Grid Connection Route to link the two.

Two access routes are also included within the Order limits. These are Wheelers Hill and Cranham Road, to the west of the Solar Farm Site, and Generals Lane to the south of the Bulls Lodge Substation Site.

## 3. Overview of Application Documentation

### Summary

The documents submitted as part of the Application have been grouped into books as detailed in Table 3-1 to accord with the Planning Inspectorate's (PINS) Advice Note Six: Preparation and submission of application documents (version 10) published in September 2021.

An additional Book has been included to capture the new documents submitted by the Applicant during the examination stage.

<b>5. Reports/Statements</b>	Contains the report and its supporting appendices relating to the pre-application consultation undertaken on the Scheme and how consultation feedback has been taken into account.
<b>6. Environmental Impact Assessment and other assessments</b>	Provides environmental information and an assessment of the likely significant effects of the Scheme, as well as a description of proposed mitigation measures.
<b>7. Other Documents</b>	Contains additional documents pertaining to the Scheme, required by the APFP Regulations regulation 6 and considered by the Applicant to be required to support the application in accordance with APFP Regulations regulation 5(2)(q).
<b>8. Examination Documents</b>	Contains the new documents submitted at each Examination Deadline.

Sections 4 to 11 of this Guide provide a summary of the purpose of the documents and plans included in each book and Appendix A provides a document schedule. The

latter is a live part of this document and will be updated during the subsequent stages of the application process.

### **Document Reference Numbering**

Documents are numbered in sequence within the respective books (as outlined in Appendix A of this Guide), with the book number being the first digit of a document number. This is followed, where relevant, by the document number, the Chapter and/or Appendix number if these are standalone documents. For example, documents within Book 1, Application Form, are numbered 1.1, 1.2, 1.3 etc.

The revision numbers of documents submitted at Examination deadlines have been updated to reflect that the documents have been updated. This updated Guide, for example, is numbered 1.2(H) as Revision 8 of the Application version. For the documents that are to be continually updated during Examination, Revision 3 will be numbered (B), Revision 4 numbered (C) etc.

## 4. Book 1: Application Form

The **Cover Letter [EN010118/APP/1.1]** provides a brief overview of the Scheme, its location, and an introduction to the Application. Cover letters were then submitted in support of the submissions made at each examination stage deadline.

The purpose of the **Guide to the Application [EN010118/APP/1.2(H)]** is referred to in section 1.1 above.

The **Application Form [EN010118/APP/1.3]** is the standard application form required by Section 37(3)(b) of the PA 2008 to be submitted with the Application and provides a high-level summary of the Scheme and the documents submitted for the Applicant's Application.

The **Section 55 Checklist [EN010118/APP/1.4]** to evidence how the Application fulfils the conditions for acceptance by the Inspectorate under section 55 of the PA 2008.

The **Electronic Application Index [EN010118/APP/1.5]** is the list of electronic file names, document reference numbers and regulation numbers for all documents provided in each book submitted with the Application.



## 5. Book 2: Plans

There are four sets of plans provided to meet the regulatory requirements in addition to the **Location Plan [EN010118/APP/2.5]** which identifies the location of the Scheme in its wider geographical context. In accordance with Regulation 5(4) of the APFP Regulations, where there are three or more separate drawing sheets a key plan is provided to enable the reader to understand the relationship between the different sheets.

The **Land Plans [EN010118/APP/2.1(A)]** correspond to the **Book of Reference [EN010118/APP/4.3(B)]** provided in Book 4 and illustrate the land required for, or affected, by the Scheme. This includes:

- land over which it is proposed to exercise powers of compulsory acquisition or any right to use land;
- land in relation which it is proposed to extinguish easements, servitudes and other private rights; and
- land over which temporary possession is sought.

The **Works Plans [EN010118/APP/2.2(B)]** illustrate the proposed location of the Scheme, and the limits of deviation within which the development and works may be carried out. The areas on the Works Plans are numbered, and these correspond to the numbered works set out in **Schedule 1 of the draft DCO [EN010118/APP/3.1(G)]** which are proposed to be authorised by the DCO.

The **Streets, Rights of Way and Access Plans [EN010118/APP/2.3(A)]** illustrate any new or altered means of access, stopping up of streets or roads and any diversions of Public Rights of Way (PRoW). No extinguishment of any part of a PRoW is proposed.

The **Traffic Regulations Plans [EN010118/APP/2.4]** show areas where temporary traffic signals, temporary road closures and temporary PRoW diversions may be required for the Scheme.

Other plans/drawings illustrating the Scheme and its environs are provided in **Environmental Statement Volume 3 – Figures [EN010118/APP/6.3]**. These included plans to show the information required by APFP Regulation 5(2)(l) and 5(2)(m).

## 6. Book 3: Draft Development Consent Order

The **Draft Development Consent Order [EN010118/APP/3.1(G)]** is the draft statutory instrument which contains the legal powers that the Applicant is seeking to enable it to construct, operate (including maintenance), and decommission the Scheme should consent be granted. It sets out the parameters for what development would be permitted. The Schedules are outlined below:

**Schedule 1 (Authorised development)** – lists the works that would be authorised by the grant of development consent, which are shown on the **Works Plans [EN010118/APP/2.2(B)]** and to which the Schedule refers.

**Schedule 2 (Requirements)** – sets out the conditions that the Applicant would be required to accord with when implementing the development authorised by the DCO.

**Schedule 3 (Legislation to be disapplied)** - lists the documents that the undertaker must have certified as true copies by the Secretary of State.

**Schedule 4 (Streets subject to street works)** – sets out the streets that would be subject to street works in connection with the development that would be authorised by the DCO.

**Schedule 5 (Alteration of streets)** – is split into three sections, the first listing the streets that would be subject to permanent alteration of layout and maintained by the Highway Authority, the second listing the streets that would be subject to permanent alteration of layout and maintained by the Street Authority, and the third listing streets that would subject to temporary alteration of layout during the life of the Scheme.

**Schedule 6 (Public rights of way)** – is split into three sections, the first detailing public rights of way to be temporarily stopped up and diverted, the second detailing public rights of way where the permanent use of motor vehicles is proposed, and the third detailing temporary management of public right of way.

**Schedule 7 (Access to works)** – contains details of the new or altered means of access that would be created as a result of the Scheme. It is split into two sections: the first detailing permanent means of access to Works and the second detailing temporary means of access to the Works.

**Schedule 8 (Traffic regulation measures)** – sets out areas where traffic regulation measures are proposed.

**Schedule 9 (Land in which only new rights etc. may be acquired)** – sets out the land over which the Applicant is seeking to acquire new land rights only rather than acquiring the entire freehold interest in that land. This Schedule should be read in conjunction with the **Land Plans [EN010118/APP/2.1(A)]**.

**Schedule 10 (Modification of compensation and compulsory purchase enactments for the creation of new rights and imposition of new restrictive covenants)** – amends relevant compulsory purchase legislation to ensure that it can apply to the DCO (particularly in connection with land and rights compulsorily acquired under the DCO).

**Schedule 11 (Land of which temporary possession may be taken)** – sets out the land of which only temporary possession may be taken, pursuant to Article 28 (Temporary use of land for constructing the authorised development).

**Schedule 12 (Hedgerows to be removed)** – sets out details of hedgerows to be removed and the reason the hedgerow removal is required.

**Schedule 13 (Documents and plans to be certified)** - contains a list of documents that would be 'certified' under the relevant article of the DCO if the DCO is made by the Secretary of State.

**Schedule 14 (Arbitration rules)** – sets out the arbitration process for how any differences under any provision of the DCO will be resolved.

**Schedule 15 (Protective provisions)** – sets out protective provisions for the benefit of statutory undertakers whose equipment may be affected by the authorised development.

**Schedule 16 (Procedure for discharge of requirements)** – provides a bespoke procedure for dealing with an application made to the relevant authority (as defined in the Schedule) for any consent, agreement or approval required or contemplated by the provisions of the DCO. It sets out time periods within which decisions must be made and provides for deemed approval of the applications in certain circumstances. It also makes provision for appeals to be made in the event of a refusal of an application or if the relevant authority requires further information to be provided in relation to that application.

The **Explanatory Memorandum to the Draft Proposed Order [EN010118/APP/3.2(B)]** explains the purpose and effect of each provision in the draft DCO including why it is considered necessary. It also identifies examples of precedents from other DCOs where applicable.

The Applicant requires a range of consents and agreements to construct and operate the Scheme. As explained in the **Explanatory Memorandum to the Draft Proposed Order [EN010118/APP/3.2(B)]** some of these are included for in the draft DCO, however there are other consents from different regulatory organisations that will be required separately to the DCO. The need for such consents and how these are to be obtained is explained in the **Consents and Agreements Position Statement [EN010118/APP/3.3(A)]**.

## 7. Compulsory Acquisition Information

Book 4 provides the evidence to justify the legal powers sought for compulsory acquisition as well as information on how the Scheme is to be funded. The **Statement of Reasons [EN010118/APP/4.1]** explains that there is a compelling case in the public interest which would justify the Applicant's exercise of powers of compulsory acquisition in order to acquire land and rights permanently and to use land temporarily to enable it to construct, operate (including maintenance) and decommission the Scheme. The Statement of Reasons also sets out the status of negotiations with landowners and the powers sought over the Order land. The **Schedule of Negotiations and Powers Sought [EN010118/APP/4.4]** should be read alongside the Statement of Reasons and sets out the status of negotiations with landowners and the powers sought over the Order land.

The **Funding Statement [EN010118/APP/4.2]** details how the Scheme, including any compulsory purchase acquisition, would be funded. The **Book of Reference [EN010118/APP/4.3(B)]** identifies all the parties who own or occupy land and/or have an interest in or right over the land affected by the Scheme, and/or who may be entitled to make a 'relevant claim' as defined in Section 57 of the PA 2008. It is structured as follows in accordance with the regulatory requirements:

**Part 1** - Names and addresses for service of each person within Categories 1 and 2 as defined in Section 57 of the 2008 Act.

**Part 2a** - Land within Order limits: Names and addresses for service of each person whose interest which may be extinguished, suspended or interfered with under section 10 of the Compulsory Purchase Act 1965, Part 1 of the Land Compensation Act 1973 or section 152(3) of the Planning Act 2008.

**Part 2b** - Land outside Order limits: Names and addresses for service of each person within category 3 that would or might make a relevant claim as defined by Section 57 of the 2008 Act.

**Part 3** - Names and addresses of those persons whose entitlement to enjoy private easements or rights may be extinguished, suspended, or interfered with.

**Part 4** - Crown Interests.

**Part 5** - Special Parliamentary Procedure, Special Category or Replacement Land.

**Part 6** - General Entries (Utilities).

## 8. Book 5: Reports/Statements

Book 5 provides the **Consultation Report [EN010118/APP/5.1(A)]** and its supporting **appendices [EN010118/APP/5.2]**. The **Consultation Report [EN010118/APP/5.1(A)]** explains how the Applicant has complied with the consultation requirements set out in the PA 2008; the APFP Regulations and the EIA Regulations. The report also accords with the guidance set out in 'Planning Act 2008: guidance on the pre-application process' published by the Department for Communities and Local Government in March 2015 and the Planning Inspectorate's Advice Note Fourteen: Compiling the Consultation Report.

The **Consultation Report [EN010118/APP/5.1(A)]** is structured as follows:

**Statutory consultation** – provides a detailed overview of the Applicant's statutory consultation between 1 June 2021 and 13 July 2021.

**Responses to the consultation** – gives a breakdown of responses received from consultees under Section 42, Section 47 and Section 48 of the PA 2008, as well as the regard had to them by the Applicant (this chapter should be read alongside Appendix J, referred to below, where the regard had to the responses is demonstrated in detail).

**Further engagement** – provides an overview of the Applicant's engagement with stakeholders following the statutory consultation, including targeted statutory consultation.

**Conclusion** – provides a conclusion on the consultation and design information undertaken, and confirms that the consultation process undertaken by the Applicant complies with the DCLG guidance on the pre-application process, as well as relevant advice from the Inspectorate.

The **Planning Statement [EN010118/APP/7.2(B)]** details the Scheme's compliance with the relevant planning policy framework, at national and local levels, and other matters which the Applicant considers are important and relevant to the Secretary of State's decision. Appendix E provides an assessment of the Scheme's harm to designated heritage assets.

The **Design Statement [EN010118/APP/7.3]** provides information regarding the context of the Scheme's location and context; the design concept; and the design principles for the proposed design solution including information regarding access and construction related design. **Appendix A of the Design Statement [EN010118/APP/7.3(B)]** sets out the **Design Principles** for the Scheme which are proposed to be secured by the DCO. The **Biodiversity Design Strategy** is provided at **Appendix B of the Design Statement [EN010118/APP/7.3]**.

The **Grid Connection Statement [EN010118/APP/7.4]** has been submitted in accordance with Regulation 6(1)(a)(i) of the APFP Regulations. It outlines the details for connecting the solar PV arrays and BESS to the National Electricity Transmission System (NETS).

The **Statutory Nuisance Statement [EN010118/APP/7.5]** identifies the matters set out in Section 79 of the Environmental Protection Act 1990 in respect of statutory nuisances and considers whether the Scheme would engage one or more of those matters, as required by Regulation 5(2)(f) of the APFP Regulations. Where any matters may be potentially engaged, this statement sets out its proposals for mitigating or limiting them.

The **Outline Battery Safety Management Plan [EN010118/APP/7.6]** explains the risks associated with BESS fires and sets out the measures proposed to minimise the impact of such an incident during construction, operation and decommissioning of the Scheme.

The **Mineral Safeguarding Assessment [EN010118/APP/7.7]** presents an assessment of the impact of the Scheme on safeguarded minerals.

The **Minerals Infrastructure Impact Assessment [EN010118/APP/7.8(A)]** presents an assessment of the impact of the Scheme on existing mineral extraction and processing infrastructure, including the consented Bulls Lodge Quarry.

The **Waste Infrastructure Impact Assessment [EN010118/APP/7.9]** presents an assessment of the impact of the Scheme on existing waste management.

The **Outline Construction Environmental Management Plan [EN010118/APP/7.10(D)]** sets out the measures that will be included in a detailed Construction Environmental Management Plan to control potential environmental and amenity impacts of construction.
