This letter is provided by the Applicant to accompany the Applicant's submissions to the Examining Authority ("ExA") for Deadline 2 of the Examination for the North Falls Offshore Wind Farm. It has been prepared in accordance with the requirements set out by the ExA in the Rule 8 Letter dated 4 February 2025 **[PD-008]** and is submitted at Deadline 2.

- 1.1.1 The Examination Timetable requests submission of the Consents and Licences Statement [AS-030] if any updates have been made for Deadline 2. The Applicant confirms that there are no updates to this document for Deadline 2.
- 1.1.2 As only minor changes have been made to the draft DCO **[6.1, (Rev 3)]** for Deadline 2, an updated version of the Explanatory Memorandum **[AS-024]** has not been submitted. The Applicant will keep the Explanatory Memorandum under review throughout the Examination.
- 1.2 Needs Case and Project Benefits Statement [2.1, (Rev 1)]
- 1.2.1 The Needs Case and Project Benefits Statement [2.1, (Rev 1)] has been updated for Deadline 2 in response to the ExA's first written questions ExQ1 1.3.1 and 1.3.3.
- 1.2.2 On the 27 February 2025 (two working days prior to this Deadline 2) the Seventh Carbon Budget (pursuant to Section 34 of the Climate Change Act 2008) was published by the Climate Change Committee (CCC).
- 1.2.3 The Applicant proposes to update the Needs Case and Project Benefits Statement [2.1, (Rev 1)] to take into account the publication of the Seventh Carbon Budget for Deadline 4 in the Examination. This will also allow for any other updates (if required) following the Issue Specific Hearings.
- 1.2.4 This is to ensure that this recent Government publication (which is important and relevant) is appropriately considered, and to ensure that the Applicant has had sufficient time to evaluate it in the context of the Needs Case and Project Benefits Statement [2.1, (Rev 1)] and any other relevant application documents (including for example ES Chapter 33 Climate Change [APP-047]).
