The following constitutes Natural England's formal statutory response for Examination Deadline 3.

1. Natural England's Deadline 3 Submissions

Natural England has reviewed the documents submitted by the Applicant at Deadlines 1 and 2. An update of Natural England's position regarding documents relevant to our remit is provided in Annex 1, including anticipated timing of responses. 2. Updated Draft Development Consent Order (DCO)

Natural England has reviewed the updated Development Consent Orders submitted at Deadline 1 and Deadline 2. We have noted that several minor changes have been made and have updated our Risks and Issues log Appendix K3 where these have progressed or addressed our concerns. Our Principal Areas of Disagreement Summary Statement (PADSS) issue P1 has been resolved by changes to Schedules 8-10 Part 2 condition 26 (3) and (4), which now include the appropriate requirement to stop piling in the event during construction noise monitoring detects underwater noise levels significantly in excess of that assessed and approved.

3. Build Option 3: Offshore Electrical Connection Supplied by a Third Party [REP1-005]

Natural England notes that [REP1-005] the consortium comprising North Falls, Five Estuaries and National Grid Energy Transmission (Sea Link) has issued a statement (Appendix E, REP1-005) supporting the Secretary of State's decision (Appendix D, REP1-005) not to continue funding for an offshore network coordination. We also note that the Applicant is retaining the offshore connection point within its project design envelope, and this is reflected in the draft DCO [REP2-008] which includes sufficient provisions to allow for Build Option 3. Although, the Applicant also states [REP1-005] that currently no third party is promoting a coordinated offshore cable option in collaboration with the North Falls proposed grid connection point. We highlight our earlier advice [RR-243] that an offshore grid connection represents the least environmentally impactful option (for marine physical processes, benthic ecology and potentially other receptors) as it would greatly reduce the need for offshore export cables to shore.

4. Margate and Long Sands Special Area of Conservation (MLS SAC) - Updated Condition Assessment (January 2025)

Natural England has updated the <u>Margate and Longs Sand SAC condition assessment</u> (January 2025). This assessment has determined the site to be in unfavourable condition due to existing anthropogenic pressures on the designate site feature. In due course, the condition assessment will be used to update the conservation advice package including setting the Conservation Objective targets to restore. Natural England highlights that this is key context for current and future decision making, in particular in regard to in-combination assessments and ensuring that projects sufficiently employ the mitigation hierarchy to minimise impacts to avoid where possible materially contributing to any in-combination assessment and taking the site further away from its restore trajectory. Therefore, we welcome the ongoing efforts of the North Falls project in adopting mitigation measures and hope that our risk and issues in relation to MLS SAC can be resolved during examination.
