The following constitutes Natural England's formal statutory response for Examination Deadline 8.

1. Natural England's Deadline 8 Submissions

Natural England has reviewed the documents submitted by the Applicant at Deadlines 6 and 7 and the RIES provided by the ExA. An update of Natural England's position regarding documents relevant to our remit is provided in Annex 1, including which Deadline 7 documents we have been able to respond to in the time available. Natural England is also submitting the following detailed responses, signposted from Annex 1:

2. Without Prejudice HRA Benthic Compensation

Natural England has reviewed the updated Without Prejudice HRA DCO schedules and in particular the newly added benthic compensation provisions. We would refer you to our relevant representation response where we provided an example benthic compensation schedule. However, in specific, we consider condition 2 (2) does not provide for the requirement to monitor any compensation measures, which would be essential to inform the need for any adaptive management. Further we note there is no requirement to have adaptive management measures approved and to implement the measures as approved. We would refer to our example schedule for appropriate details to be included in such provisions. With regard to conditions 2 (1) and 3 (1) we consider the provisions for securing strategic compensation to be incomplete as they do not account for any need for monitoring or adaptive measures, again we would refer to the example compensation schedule submitted with our relevant representations. [NB: Detailed comments on Benthic compensation measures can be found at Appendix C8.2 to this response]

Natural England would advise that the coordinates at condition 7 are checked for accuracy as due to the short period of this consultation we have not been able to review their appropriateness.

3. Impacts on Outer Thames Estuary Special Protection Area red-throated diver

Whilst the Applicant has generally made good progress in resolving offshore ornithology issues, there has been no progress regarding the predicted impacts of the development on red-throated diver (RTD) from the Outer Thames Estuary Special Protection Area (OTE SPA). We recognise that achieving further increases in the separation distance between the array and SPA would be very challenging in the context of maintaining a viable project. However, we consider that a seasonal restriction to cable laying and associated activities within the SPA and a 2km buffer (between 1st November and 31st March inclusive) is a feasible mitigation option. This mitigation measure has been used by other developers affecting the OTE SPA e.g. East Anglia One North and East Anglia Two OWF, and more recently Five Estuaries OWF have put a seasonal restriction in place for the SPA, with discussions ongoing regarding the 2km buffer. These commitments reflect broader practice elsewhere in the UK, with Outer Dowsing OWF, Mona OWF and the Morgan & Morecambe Transmission Assets proposals all committing to seasonal restrictions to avoid adverse effects on other red-throated diver SPAs.
