In considering this documentation, please note the following:

- 4. The Application Document Tracker and Application Guide have been updated to reflect the latest status and list of documents submitted as part of the Examination process.
- 5. The Draft Development Consent Order has been updated to reflect changes arising from Northern Endurance Partnership taking over the HLCP project from NGCL, an update to Requirement 7(1) following discussions with the Environment Agency, and other minor grammatical changes and updates to reflect updated document references.
- 6. The Schedule of Changes to the Draft Development Consent Order has been updated to detail these changes.
- 7. The Statement of Reasons has been updated to provide a consolidated version as requested by the ExA in their Procedural Decision dated 26/04/23.
- 8. The Schedule of Negotiations and Powers Sought document has been updated following the submission of the Second Changes Application to set out the engagement that the Applicant has undertaken in respect of those amendments.
- 9. The Funding Statement has been updated to provide a consolidated version as requested by the ExA in their Procedural Decision dated 26/04/23.
- 10. The REAC has been updated to reflect the commitment to the provision of a Stakeholder Communication Plan (Ref ID G21), as confirmed in the Applicant's response to WQ2 GEN.2.2.

- 11. The Outline Landscape and Biodiversity Strategy has been updated to reflect the Applicant's response to the Examining Authority's Second Written Questions and to provide clarity on the retention of vegetation.
- 12. The Draft Lighting Strategy has been updated to reflect discussions with NYC regarding the information that would be included in the detailed Lighting Strategy.
- 13. The Habitats Regulations Assessment (HRA) is submitted as the concluding HRA Report and to note no further work is required on the HRA following agreement with Natural England. The HRA has been updated to incorporate:
  - to capture cumulative updates (regarding two developments Short List ID103 and ID106);
  - the Second Changes Application; and
  - to capture updates relating to Appendix 8 (Lower Derwent Valley Habitats and Soil Analysis) of the HRA having been submitted.
- 14. The Biodiversity Net Gain (BNG) Assessment has been updated to reflect:
  - the changes to Work No. 8 as a result of the Second Change Application;
  - set out clearly how the delivery of BNG is secured; and
  - the recent updates around the River BNG work and Colne and Calder Rivers Trust project.
- 15. The Applicant continues to engage with all SoCG parties, and will submit updated Statements of Common Ground (SoCGs) to reflect the status of ongoing discussions with the applicable stakeholders at Deadline 7. Similarly, the Statement of Commonality will be updated at Deadline 7 to reflect updates to SoCGs and the position more generally at that time.
- 16. The National Policy Statement Compliance Tracker (EN-1 and EN-3) has been updated, having also noted the additional points raised via the ExA's Second Written Questions.
- 17. The Applicant's comments on Interested Parties' submissions at Deadline 5 is provided in Document 8.10.5.
- 18. The Applicant's responses to the ExA's Second Written Questions are provided in Document 8.16.
- 19. The draft Section 106 Agreement is being discussed with the North Yorkshire Council (NYC). The parties are discussing a minor proposed amendment to address further comments made by NYC at the hearings (as recorded in the Applicant's oral summary of submissions made at ISH4 (REP4-030), in particular paragraphs 9.6 9.8 in respect of BNG). This is the only outstanding point of drafting for the agreement, and it is anticipated it will be in agreed form and ready for execution by the parties shortly. The Applicant will provide a further update at Deadline 7.

- 20. Enclosed with this letter are the above documents via the file upload facility on the project application website<sup>1</sup>, as agreed with the Inspectorate via the Rule 6 letter on 13 December 2022.
