The Applicant and Spirit Energy have been working on agreed Protective Provisions in response to question 10:

Commercial negotiations and agreements

10. The Applicant and Spirit Energy are invited to provide an update on progress towards a commercial agreement to replace the proposed Protective Provisions

for the protection of Spirit Energy's interests. Alternatively, if it has not yet been possible to finalise a commercial agreement, the Applicant and Spirit Energy are invited to provide an update on whether agreement has been reached on any specific areas of disagreement between the parties which remained outstanding at the conclusion of the Examination, as to the form of Protective Provisions which should be included in a final Development Consent Order in the absence of a commercial agreement. It is the Secretary of State's expectation that the parties should continue to endeavour to reach agreement on as many outstanding issues as possible, and provide updates accordingly.

Negotiations between Spirit and the Applicant have recently progressed, and it is anticipated that agreement in principle will shortly be reached. However, the details, terms and documentation still require to be worked through before a meaningful update can be provided. On that basis, the Applicant and Spirit Energy, cc. into this email, are writing to jointly request an extension to this question. It is our intention to submit a response to the above noted question by 23:59 on 17 October 2025, at the latest.

For the avoidance of doubt, the Applicant will be submitting response to the remaining questions in the SoS Rfl by 23:59 on 10 October 2025.
