# The Oaklands Farm Solar Park Order (Correction) Order 2025

The Oaklands Farm Solar Park Order 2025(**a**), which granted development consent within the meaning of the Planning Act 2008(**b**) ("the Act") contains a correctable error within the meaning of paragraph 1 of Schedule 4 to the Act.
