# The Oaklands Farm Solar Park (Correction) Order 2025

Made - - - - 8th October 2025

Coming into force - 9th October 2025

The Oaklands Farm Solar Park Order 2025 ("the 2025 Order")(a), which granted development consent within the meaning of the Planning Act 2008(b) ("the Act") contains correctable errors within the meaning of paragraph 1 of Schedule 4 to the Act.

In accordance with paragraph 1(5)(a) of Schedule 4 to the Act, before the end of the relevant period(c), the Secretary of State received a written request from the applicant(d) for the correction of errors in the 2025 Order.

#### Citation and commencement

1. This Order may be cited as the Oaklands Farm Solar Park (Correction) Order 2025 and comes into force on 9th October 2025.
