An application has been made to the Secretary of State under paragraph 2 of Schedule 6 to the Planning Act 2008(a) in accordance with the Infrastructure Planning (Changes to, and Revocation of, Development Consent Orders) Regulations 2011(b) for a non-material change to The Oaklands Farm Solar Park Order 2025(c).

The Secretary of State, having considered the application, the responses to the publicity and consultation required by regulations 6 and 7 of the Infrastructure Planning (Changes to, and Revocation of, Development Consent Orders) Regulations 2011, has decided to make the changes on terms that in the opinion of the Secretary of State are not materially different from those proposed in the application.

The Secretary of State, in exercise of the powers conferred by paragraph 2 of Schedule 6 to the Planning Act 2008, makes the following Order—

Citation and commencement

1. This Order may be cited as The Oaklands Farm Solar Park (Amendment) Order 202[] and comes into force on [].

Amendment of The Oaklands Farm Solar Park Order 2025

2. The Oaklands Farm Solar Park Order 2025 (“the 2025 Order”) is amended in accordance with this Order.
