The Heckington Fen Solar Park (Correction) Order 2025

Made - - - - 11th April 2025

Coming into force 14th April 2025

The Heckington Fen Solar Park Order 2025 ("the 2025 Order")(a) which granted development consent within the meaning of the Planning Act 2008 ("the Act")(b) contains correctable errors within the meaning of paragraph 1 of Schedule 4 to the Act.
