Deadline 4 Cover Letter

The Applicants note and welcome your appointment to the Examining Authority [PD-019]. We wish Ms Dowling well and trust the handover of the Lead Examiner role can be delivered efficiently.

This letter summarises and explains the content of the Applicants' submissions to Deadline 4 of the Examination. Documents are described in the order requested by the Examination Timetable contained in the Rule 8 letter [PD-011]. This letter also responds to the Examining Authority's Rule 17 letter [PD-019] of 15 April 2025.

The Applicants have noted the consultation on revisions to EN-3 launched by DESNZ on 24 April 2025, which include proposed new wording regarding wake effects. For the avoidance of doubt, the Applicants have not attempted to address the implications of this consultation, given the shortage of time before Deadline 4.

Post hearing submissions

The Applicants' summaries of oral submissions are provided in 14.2 The Applicants' Written Summaries of Oral Submissions made at CAH2, ISH3, ISH4 and ISH5. Over the course of the recent examination hearings, various other documents were requested to be provided by the Applicants, as set out in the Action Points [EV7-002, EV8-009, EV9-002 and EV10-002]. These are provided in 14.3 The Applicants' Comments on the Responses to ExQ1.

Updated draft DCO

Revision 7 of **3.1 Draft Development Consent Order** is now provided alongside **3.2** Explanatory Memorandum, both clean and tracked, with 3.4 Schedule of Changes to **dDCO** to explain the amendments.

Updated Land Rights Tracker

Revision 4 of **10.4 Land Rights Tracker** is now provided clean and tracked.

Updated Book of Reference

Revision 6 of **4.2 Book of Reference** is now provided clean and tracked.

Following changes to land ownership due to the implementation of the Jocks Lodge Junction works, in addition to updating 3.2 Book of Reference, the Applicants are also providing revised 4.7 Land Plans and 4.9 Crown Land Plans.

Updated SoCGs

All twenty Statements of Common Ground have been updated at document references 9.2 to 9.22. Notably the Applicants have now resolved all areas of disagreement with the Humberside Archaeological Partnership, Trinity House and the UK Chamber of Shipping.

The ExA issued a Rule 17 letter on 3 March 2025 [PD-016]. The Applicants acknowledge the request for a revised Environmental Statement.

The Applicants welcome the ExA's request for interested parties to provide information on time, and note that the Applicants have been funding multiple parties (including Natural England and the Marine Management Organisation) to have necessary resources in place.

The Applicants also welcome the ExA's request for interested parties to attend hearings, and re-iterate their preference for in-person hearings. An early indication of the likely subject matter of the June hearings will facilitate technical expert availability.
