1 Guide to the Application

1.1 Introduction

- 1. This document provides a guide to RWE Renewables UK Dogger Bank South (West) Limited and RWE Renewables UK Dogger Bank South (East) Limited's (herein referred to as the 'Applicants') Development Consent Order (DCO) application for the Dogger Bank South (DBS) East and DBS West Offshore Wind Farms, collectively known as DBS offshore wind farms (herein 'the Projects'). It sets out which document version is the most up to date.
- 2. This is a live document and will be updated when updates or revisions to existing documents are made and when new documents are submitted to the Planning Inspectorate.





Plate 1-1 - Diagram of Relationship between draft DCO Requirements and Onshore Documents








Plate 1-2 - Diagram of Relationship between draft DCO Deemed Marine Licence Conditions and Offshore Documents
