# **Request for Information response**

The Applicants are pleased to respond to the Secretary of State's Request for Information issued on 6 November 2025. This response comprises answers to questions in 22.2 The Applicants' Response to the Secretary of State's Request For Information, supported by updates to documents and new documents, as detailed in this letter. A full list of material provided is set out in Appendix A of this letter.

### **Crown Consent**

The Applicants are pleased to confirm that Crown Consent has been obtained, as evidenced in 22.4 The Crown Estate's Letter of Consent.

## **Habitats Regulations Assessment**

The Applicants have continued negotiations with Natural England as the Statutory Nature Conservation Body and have reached further consensus on compensation proposals. 22.7 Kittiwake Compensation and Artificial Nesting Structure Update and 22.8 Guillemot and Razorbill Compensation Update were both provided to Natural England for discussion to assist with this, resulting in updates to the following documents:

- 6.2.1 Appendix 1 Project Level Kittiwake Compensation Plan (Revision 8)
- 6.2.1.2 Outline Kittiwake Compensation Implementation and Monitoring Plan (Revision 4)
- 6.2.2 Appendix 2 Guillemot [and Razorbill] Compensation Plan (Revision 8)
- 6.2.2.1 Annex A Outline Guillemot and Razorbill Compensation Implementation and Monitoring Plan (Revision 4)

Whilst the Applicants have tried to engage directly with NatureScot for a number of months, to discuss the development of the project-led auk compensation options in Scotland in further detail, it has not been possible to meet since the meeting of 3 October 2025. The Applicants received a copy of NatureScot's letter to the Secretary of State of 2 December 2025. A response to the points raised is provided at 22.5 The Applicants' Response to NatureScot's DESNZ letter.





The Applicants have also produced 22.3 The Applicants' Position on Compliance with Legal and Policy Requirements for Compensatory Measures to support the Applicants' position that compensation measures for the Projects are suitably progressed to permit a timely DCO Approval.

As requested by the Secretary of State, the Applicants have updated **8.6 Commitments Register** (Revision 5), **8.20 Cable Statement** (Revision 6) and **8.23 In-Principle Monitoring Plan** (Revision 7).

# **Environmental Impact Assessment**

The Applicants and Marine Management Organisation (MMO) have provided an update to their Statement of Common Ground (SoCG) [REP9-013] on the topic of fish and shellfish at 22.6 MMO SoCG Update. This records new agreement in relation to the methodology in 7.10.10.3 Appendix 10-3 Back-calculation of the Peak Atlantic Herring Spawning Period (Revision 3).

## Air Defence Radar

The Applicants have sought the opinion of the Ministry of Defence on the wording proposed by the Secretary of State in your letter dated 6 November 2025. The Applicant has received a copy of the letter sent from the Ministry of Defence to DESNZ on 3<sup>rd</sup> December 2025 (Ministry of Defence reference DIO10053433) which confirms the Ministry of Defence considers the draft DCO wording agreed previously with the Applicant is appropriate and restrictions on the erection of any part of the wind turbine generators within Work No. 1B is not considered necessary. Following this, both parties confirm their proposed Requirement wording within the Order and strong preference for no change to this agreed wording.

#### **Wake Effects**

The Applicants' response is contained within our main document, 22.2 The Applicants' Response to the Secretary of State's Request For Information.

## **Land Rights**

The Applicants have provided a new update to **10.4 Land Rights Tracker (Revision 10)**. This shows further progress in obtaining land rights by negotiation.

Agreement on protective provisions with Network Rail has been reached, which is now reflected in a revision of **9.14 Network Rail SoCG (Revision 4)**. The Applicants anticipate that Network Rail will now withdraw their objection.

Agreement has also been reached with Northern PowerGrid that the existing protective provisions in the draft DCO meet their needs; confirmation that their objection is withdrawn is included in 22.9 Northern PowerGrid's Objection withdrawal letter.

## Draft Development Consent (DCO) Order

To accommodate the changes arising from the agreements discussed above, a new revision of 3.1 **Draft DCO (Revision 13)** is provided, alongside 3.2 **Explanatory Memorandum (Revision 12)**. To aid navigation the Applicants have also updated 3.4 **Schedule of Changes to dDCO (To Revision 13) (Revision 11)**.







## Conclusion

The Applicants are happy to respond fully to this Request for Information, having shared and agreed positions with regulators prior to submission. This should obviate the need for further consultation, allowing the Secretary of State to determine the application in January to prevent further delays to those already encountered in the pre-application period.

A timely grant of this DCO will permit the Applicants to install 3GW of clean power, addressing the need and urgency expressed in government energy and planning policies.
