Planning Act 2008 – Application for Development Consent GT R4 Limited, trading as Outer Dowsing Offshore Wind ("the Applicant") The Proposed Outer Dowsing Offshore Wind Farm Order Application Reference: EN010130

The Applicant has submitted a range of documents at Deadline 4a as listed and described in Table 1 below.

In addition to those documents provided in response to Examining Authority ("ExA") requests in the Rule 8(3) Letter (PD-022) and as a result of Issue Specific Hearing ("ISH") 5 and 6 Action Points, the Applicant has provided additional documents for the reasons set out in Table 1 and highlighted in this letter. On the basis of discussion with the ExA at ISH 5 and 6 about the status of engagement with certain Interested Parties ("IPs"), an update on this information is set out in Table 2.

The Applicant highlights the following points regarding Deadline 4a submissions to the ExA.

(i) ES Chapter Updates

In ISH 2, and as further discussed at ISH5-6, the Applicant noted its intention to provide updates to Environmental Statement ("ES") Chapters at Deadline 5 in order to, where relevant, reflect: clarifications made to date during the Examination; corrections to errata; additional commitments made through Examination; and changes to status of or addition of cumulative projects. The Applicant has brought forward as many of these ES chapter updates as possible to this deadline from Deadline 5 in response to the ExA's request for the Applicant to do so. Documents listed in Table 1 have been submitted at D4a, those not listed below and which require to be updated will be provided at Deadline 5 as necessary.

In particular, the Applicant notes that the update to Chapter 12 Offshore and Intertidal Ornithology (6.1.12) provided at this Deadline includes the submission of three additional appendices. These are documents which are already before the Examination (Levels of precaution in the assessment and compensation calculations for offshore ornithology (REP2-



057); Consideration of bioseasons in the assessment of guillemot (REP2-058); and Rates of displacement in guillemot and razorbill (REP2-059). These documents are referred to in the updated Chapter 12 (6.1.12) and so have been included as an Appendix to that Chapter (with minor amendments to the previously submitted versions to update definitions). An additional Appendix has also been submitted in relation to Chapter 25, Land Use (6.1.25) provided at this Deadline. Again this document is already before the Examination (Previously titled BMV Quantitative Cumulative Assessment) (REP4-117)). This document is referred to in the updated Chapter 25 (6.1.25) and so has been included as an Appendix to that Chapter (with some amendments to reflect updates to the Chapter).

(ii) Updates to on-going discussion with Interested Parties

As above, an update on the engagement with certain IPs (Natural England; the Marine Management Organisation ("MMO") and TH Clements) is presented in Table 2 in short form for the assistance of the ExA following discussion of outstanding areas of disagreement at ISH5 and 6 and the request by the ExA for all parties to redouble efforts on outstanding disagreement.

(iii) Change Notifications:

The Applicant's Change Notification dated 20 February 2025

Further to the discussion of outstanding areas of difference between the Applicant and IPs and in order to seek to narrow such issues, the Applicant proposed the introduction of a number of Project commitments and refinements at set out in 21.22 The Applicant's Change Notification dated 20 February 2025. The Applicant welcomes the confirmation in the ExA's Procedural Decision dated 25 February 2025 (PD-024) that the proposed updates do not require a formal change request to be submitted. Following that procedural decision, the Applicant confirms that the following documents have been updated and submitted to reflect the Changes:

- Outline Cable Specification and Installation Plan (8.5)
- Outline Scour Protection and Cable Protection Management Plan (8.21)
- Draft Development Consent Order (3.1)
- Explanatory Memorandum (3.2); and
- Schedule of Changes to the DCO (3.1.1).

The Applicant notes that updates to the following documents will also be required to reflect Change 2 described in the Applicant's Change Notification dated 20 February 2025 (narrowing of benthic compensation options) and these will be submitted at Deadline 5:

- Without Prejudice Sandbank Compensation Plan (REP4-047);
- Without Prejudice Biogenic Reef Compensation Plan (REP4-049); and
- Without Prejudice Benthic Compensation Evidence Base and Roadmap (REP4-051).

In relation to Change 1 (a commitment to the installation of removeable cable protection on defined areas of supporting habitat for *S. spinulosa* reef within the Inner Dowsing, Race Bank and North Ridge Special Area of Conservation ("IDRBNR SAC")), the Applicant provided a technical note to Natural England on the 18th February 2025 in support of the definition of its proposed commitment to removal cable protection in areas of supporting habitat for *Sabellaria spinulosa* reef. Natural England provided initial feedback on this on the 24th



February 2025. The Applicant is currently considering this feedback and will respond in due course.

21.18 The Applicant's Change Notification (REP4-123; submitted at Deadline 4)

The Applicant welcomes the ExA's confirmation (PD-022) that "these proposed changes fall within the broad description of changes to the draft DCO as articles are reviewed, drafting is improved, or requirements are developed and that they are not such substantial changes that they would warrant a formal Change Request". Following that procedural decision, the Applicant confirms that the following documents have been updated and submitted to reflect the Changes:

- Outline Public Access Management Plan (8.17)
- Public Rights of Way Plan (2.10)
- Onshore Crossing Plan (2.18);
- Onshore Crossing Schedule (6.3.3.2);
- Draft Development Consent Order (3.1) and
- Schedule of Changes to the DCO (3.1.1)

(iv) Updated dDCO

The DCO and accompanying documents (Documents 3.1; 3.1.1; and 3.2) have been updated at this deadline as described in the Schedule of Changes to the DCO. This includes updates made as a result of on-going engagement with Interested Parties as well as general drafting changes made as articles are reviewed, drafting is improved, or requirements are developed and those highlighted in the Applicant's Change Notification dated 25 February 2025.

(v) ISH5 and ISH6 Action Points

Detail on how the actions are addressed is contained in the Applicant's Written Summaries of Oral Cases Put at the Issue Specific Hearing 5 and 6 (Documents 22.4 and 22.5) and The Applicant's Response to Actions Points recorded at ISH5 and ISH6 (Document 22.9). Depending on the nature of the Action Points and the length and nature of the response required by the Applicant, the Action Points have either been dealt with in the Hearing Summaries themselves, in Document 22.9, or in stand-alone notes. Where Action Points are not dealt with in Document 22.9 itself, Document 22.9 sets out where this information can be found.

(vi) Report on the Implications for European Sites ("RIES")

The Applicant agreed during ISH6 that it would respond to as many of the RIES questions as possible at Deadline 4a despite the formal examination deadline (Deadline 5). In Appendix 4 of Document 22.9 the Applicant has provided answers to as many of the RIES questions as it was able by Deadline 4a. The remaining questions will be responded to at Deadline 5.

The Applicant highlights the following additional points relating to future deadlines:

(vii) Further Benthic; Ornithology; HRA documents: In line with its commitment to inform the ExA of its intention to submit further documents related to these topics at future deadlines, the Applicant notes:



Deadline 5 submissions discussed at ISH2; ISH5; ISH6

As discussed above, the Applicant will provide any remaining ES Chapter / Appendix updates related to these subjects at Deadline 5, having sought to deliver as many ES Chapter updates as possible at Deadline 4a.

Other documents:

In addition, as a result of extra mitigations provided by the Applicant at Deadline 4a, minor updates will be made to the Report to Information Appropriate Assessment.

As discussed in the Applicant's Change Notification dated 20 February 2025, the Applicant is considering the potential introduction of temporal piling restrictions for the protection of herring during the spawning season, covering defined areas within the Array and the northern ANS area. Should the Applicant proceed with these temporal piling restrictions, relevant documents will be updated and submitted accordingly.

Table 1.2 of the Applicant's Comments on Deadline 4 Submissions (Document 22.3) responds to each of the points raised by the MMO including identifying, where appropriate, the areas in which matters have progressed as a result of these further discussions.

Natural England	 In relation to offshore matters: Following meetings in January and advice provided by Natural England to the Applicant at deadline 3, the further commitments have made by ODOW as discussed in Deadline 4a documents and as summarised below: a commitment to the installation of removeable cable protection on defined areas of supporting habitat for S. spinulosa reef within the Inner Dowsing, Race Bank and North Ridge Special Area of Conservation ("IDRBNR SAC") narrowing the options that may be pursued as compensation measures for impacts on the sandbank and biogenic reef features of the IDRBNR SAC; removal of the option to install gravity base structure ("GBS") foundations for the Offshore Reactive Compensation Platforms ("ORCP") to reduce the maximum design scenario for marine physical processes effects; and the introduction of a seasonal restriction for construction works related to the offshore export cable and the installation of the ORCP within the Greater Wash Special Protection Area to further mitigate impacts on overwintering red-throated diver.
	The Applicant awaits further feedback and hopes that commitments made will allow for the resolution of the matters to which they relate by Deadline 5. In relation to onshore matters: The Applicant has met with Natural England specifically to discuss the proposed mitigation at the Wash SPA, further details in respect of which are outlined in response to ISH5 Action Points 7 and 8 and additional wording added into the OLEMS.
