Application by GT R4 Limited (trading as Outer Dowsing Offshore Wind) for an Order Granting Development Consent for the Outer Dowsing Offshore Wind Project

The following constitutes Natural England's formal statutory response for the Outer Dowsing Offshore Windfarm (ODOW) Examination Deadline 6.

1. Natural England's Deadline 6 Submissions

For Deadline 6, Natural England has reviewed the documents relevant to our statutory remit submitted by the Applicant at Deadline 5 on 13 March 2025. An update of Natural England's position regarding these documents is provided in Annex 1, including an indication where responses were deferred from a previous deadline. 2. Natural England's Final Position

The Risk & Issues log and PADSS within Appendix J6, submitted on 04 April 2025 at Deadline 6 represents Natural England's position at the close of the Examination. Further clarification of our final positions is also included within Appendices C7, E4, F6 and G5 submitted at Deadline 6.

3. Rule 17 Letter - Request for Information

Natural England's response to The Infrastructure Planning (Examination Procedure) Rules 2010 Rule 17 Letter 21 March 2025 is included within Appendix K4.

4. Statement of Common Ground

Natural England has reviewed the Applicant's SoCG for marine processes, benthic ecology, benthic compensation and marine mammals. For the other SoCG's, due to time constraints

and the volume and complexity of documents to review and provide advice and formulate our final position at Deadline 6, Natural England was unable to review and provide input to our position within these remaining SoCG documents in a timely manner.

Please be advised that Natural England's focus for Deadline 6 has been to provide advice to the documents submitted at Deadline 5 and as requested work directly with the Applicant on issue resolution.

It is Natural England's view that the final Principal Area of Disagreement Summary Statement (PADSS) and our Risks and Issue Log are an effective tool for the Examining Authority to understand where Natural England has determined issue resolution and where outstanding areas of disagreement remain and the implication of these.

5. Project Lifetime

Natural England notes that the Applicant has stated in [REP5-016] that whilst 35 years has been assumed as a reasonable high-level estimate of the operational period, it has not been treated as an assumed limit to the operational lifetime of the development. Furthermore, it is stated that "each relevant chapter author has considered the implications of a longer operational period in arriving at the relevant conclusions on likely significant effects and confirmed that the conclusions reported would remain the same after 35 years without new or different likely significant effects" [REP5-016]. We advise that there are likely to be limits to the supporting evidence and therefore the appropriateness of the EIA and HRAs beyond 35 years, especially where modelling has been used. For the Applicant's assertion to be given weight, we consider that the Applicant's submissions would have needed to clearly demonstrate how they have considered the implications of a longer operational period within the impact assessment for marine physical processes, benthic ecology, marine mammals and offshore ornithology, including consideration of climate change impacts and increased storminess

If at the time of consent this is unable to be demonstrated, we advise that an operational end date of 35 years is included within the dML, which we understand to be aligned with standard best practice for all non-Offshore wind marine licences. Whilst this is a new issue included within the Natural England's Risk and Issue Log Appendix J6 and PADSS, this has been discussed in this Examination since the first set of Examiners questions [ref. Q1 DCO 1.9]. It is also discussed in Appendix B4 as part of our Deadline 6 submission

For awareness, we note during discussions on this matter with the MMO, that this has highlighted a potential cross cutting issue with offshore windfarm marine licences. Natural England considers that there is a benefit to including an end date of the operational phase within the DCO/dML to ensure that it is clear that any repowering etc. would be subject to a new consent or variation, which would also require a full reassessment of impacts. Natural

England notes this is also supported by the MMO. For awareness, Natural England will also

be advising the inclusion of an operational end date on the dML for all OWF NSIPs

Applications currently in examination.

6. Onshore Ecology and Onshore Ornithology

Since Deadline 5, Natural England has worked directly with the Applicant on outstanding issues in relation to onshore ecology and onshore ornithology matters. In response to our advice during this period, Natural England understands the Applicant will provide updates to

several documents and plans at Deadline 6. For transparency our advice is included within

Appendix 14.

In relation to this, Natural England's current position regarding Air Quality (dust monitoring)

and commitments to monitoring of Noise Disturbance and mitigation measures within the

latest Outline Landscape and Ecological Management Strategy (REP5-122, REP5-120),

Outline Soil Management Plan (REP5-116), Outline Code of Construction of Practice (REP5-

114) are set out within Appendix J6 Natural England's Risk and Issues Log, Tab H and Tab I.

7. In Principle Monitoring Plan (IPMP) [REP4a-074]

In Appendix L1 Natural England has outlined our overarching position regarding the latest version of the IPMP [REP4a-074], along with highlighting issues that remain outstanding from

our advice provided at Deadline 3 and 5.
