## 6 Guide to the Application

### 6.1 Introduction

1. Outer Dowsing Offshore Wind (The Applicant) has applied to the Secretary of State under the Planning Act 2008 for powers to construct, operate and decommission the Outer Dowsing Offshore Wind Project (The Project).
2. This document provides a guide to the Applicant's Development Consent Order (DCO) application (the Application) for the Project. It sets out how to navigate the different Parts and Volumes of material submitted as part of the Application.
3. This forms the base of a live document which will be updated throughout examination when updates or revisions to existing documents are made and when new documents are submitted to the Planning Inspectorate, highlighting the most up to date versions of each document.

### 6.2 Master Document List

4. For ease of navigation these documents are grouped into three sections, documents submitted as Application documents, documents submitted post Application and prior to the commencement of the Examination, and the third Examination section.
