Please see below a statement on behalf of The Crown Estate in response to the request for information issued 10 December 2025 Ref: EN010130.

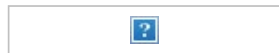
The Crown Estate have continued to negotiate with Outer Dowsing Offshore Wind limited, further to these negotiations the following statement has been agreed jointly by the parties:

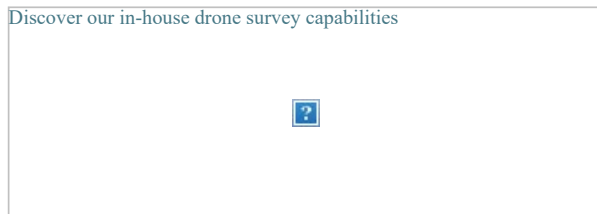
