PROPOSED GATE BURTON ENERGY PARK

PLANNING ACT 2008 SECTION 46: DUTY TO NOTIFY SECRETARY OF STATE OF PROPOSED APPLICATION

I write on behalf of Gate Burton Energy Park Limited (the "Applicant") to notify the Secretary of State in accordance with section 46 of the Planning Act 2008 (as amended) (the "Act"), of our intention to submit a Development Consent Order ("DCO") application to the Secretary of State for Business, Energy and Industrial Strategy to authorise the construction, operation (including maintenance) and decommissioning of the proposed Gate Burton Energy Park. The Applicant intends to make this application in Q4 2022.

We have previously provided notification pursuant to Regulation 8(1)(b) of the Infrastructure Planning (Environmental Impact Assessment) Regulations 2017 that the Scheme is an Environmental Impact Assessment ("EIA development"), as defined by those regulations, accordingly an Environmental Statement will be submitted as part of our DCO application.

The submission of the application will follow a period of statutory pre-application consultation carried out pursuant to sections 42, 47 and 48 of the Act, the Infrastructure Planning (Applications: Prescribed Forms and Procedures) Regulations 2009 (the "APFP Regulations"), and the Infrastructure Planning (Environmental Impact Assessment) Regulations 2017. The statutory consultation will commence on 22nd June 2022 and end on 5th August 2022, a period of 44 days.

Summary of the Scheme

The Gate Burton Energy Park will comprise the construction, operation and maintenance, and decommissioning of a solar photovoltaic (PV) array generating facility and energy storage facility with a total capacity exceeding 50 megawatts (MW) with an export connection to the National Grid via a connection corridor to Cottam substation ("The Scheme").

The Application is for the proposed Gate Burton Energy Park on farmland south east of Gainsborough and to the east of the A156 at Gate Burton and to the west of the B1241 at Willingham by Stow (the "Site"). The Application comprises of the 'Solar and Energy Storage Park' and a grid cable connection corridor to National Grid's 400kv Cottam substation which is located to the SW of the Site in Nottinghamshire covering an area of approximately 1,426 hectares (ha) ("the DCO Site"). Of the DCO Site, around 80% is likely to be used for the location of the PV Arrays, with other areas being used for the Battery Energy Storage Systems (BESS), substation, underground cabling, access tracks, some ancillary buildings as well as areas of landscaping and biodiversity enhancement.

The Scheme's main proposals in summary are:

- Solar photovoltaic (PV) panels;
- Battery energy storage system;
- Associated energy infrastructure (e.g. power conversion stations and cabling) and ancillary works;
- On-site substation; and
- A grid cable connection corridor to National Grid's 400kV Cottam substation located in Nottinghamshire.

In addition, any necessary rights and powers will be sought to ensure delivery of the Scheme, including compulsory acquisition of land or an interest in or right over land and temporary use powers and, if required, powers to apply and/or disapply legislation relevant to the Scheme.
