The West Burton Solar Project (Correction) Order 2025

The West Burton Solar Project Order 2025 ("the Order")(a), which granted development consent within the meaning of the Planning Act 2008 ("the Act")(b), contains correctable errors within the meaning of paragraph 1 of Schedule 4 to the Act.

In accordance with paragraph 1(5)(a) of Schedule 4 to the Act, before the end of the relevant period (as defined in paragraph 1(6)(a) of Schedule 4 to the Act), the Secretary of State received a written request from the applicant(c) for the correction of errors in the Order.

In accordance with paragraph 1(7) of Schedule 4 to the Act, the Secretary of State has informed Lincolnshire County Council, Nottinghamshire County Council, West Lindsey District Council and Bassetlaw District Council as the relevant local planning authorities(d), that the request has been received.

The Secretary of State, in exercise of the powers conferred by section 119, and paragraphs 1(4) and 1(8) of Schedule 4 to the Act, makes the following order—

Citation, commencement and interpretation

- 1.—(1) This Order may be cited as the West Burton Solar Project (Correction) Order 2025 and comes into force on 4th June 2025.
 - (2) In this Order, "the 2025 Order" means the West Burton Solar Project Order 2025(e).

- **2.**—(1) The 2025 Order is corrected in accordance with paragraphs (2) and (3).
